Consent Agenda Items

Required Vote: Simple Majority

<u>Please Note</u>: Items listed under the Consent Agenda are considered routine or otherwise. Each item will be read individually into the record of Convention and the Consent Agenda will then be enacted as a whole by one motion and one roll call. There will be no separate discussion of these items. If discussion and separate discussion by Convention is desired on any Consent Agenda item, any Delegate

may request to remove that item, and such item will be removed from the Consent Agenda by the Chair of Convention and considered in its normal sequence under the Regular Order of Business.

RESOLUTION TO GRANT SEAT AND VOICE

Resolved, that as a courtesy, clergy who are currently licensed in this Diocese, all lay members of Standing Committee and Diocesan Council who are not delegates, lay members of the Commission on Ministry, and lay deputies to General Convention, representatives of Church of the Resurrection in Merced, an unorganized mission, and all clergy and lay persons registered with the Credentials Committee as official observers to this 65th Annual Convention, all be granted seat and voice at this Annual Convention of the Episcopal Diocese of San Joaquin, meeting at ECCO, November 9, 2024.

RESOLUTION TO LIMIT DEBATE

Resolved, that in order to provide adequate voice to as many officers, delegates, and official observers of the Convention as possible, debate on any item of the agenda shall be limited to two (2) minutes per person. Convention Delegates may give of their time to another, but no single individual may exceed five minutes on any one motion. As a matter of courtesy, motions to "Call the question" or "Call the previous question" is out of order as long as one or more delegates have been acknowledged by the moderator are in the queue awaiting a turn to speak, unless there have been already five persons speaking for and/or against the issue.

RESOLUTION ON DISPATCH OF BUSINESS

Resolved, that the Chair of Convention and the Committee on the Dispatch of Business are permitted flexibility in presenting and re-ordering the agenda in order to expedite the business of convention.

RESOLUTION TO WAIVE READING OF RESOLUTIONS

Resolved, that in the interest of expediting the business of the Convention, the reading of those Resolutions submitted prior to convention and available to delegates and voting clergy in the Convention Booklet will be waived.



"Chapter members shall be elected for a (3) three-year period on a rotating basis, four (4) being chosen on the third Sunday of October each year by the Cathedral congregation...Following a confirming vote by the Diocesan Convention, persons elected to Chapter shall assume office at the annual meeting of the Cathedral congregation."

Treasurer's Report

DFMS (Domestic & Foreign Missionary Society) Investment Account

The Balance Sheet shows Account #11111 DFMS 1178-Diocesan Reserve. This account is providing all but 14% of budgeted income in 2024 and is critical to our existence as a Diocese. I have been working with Chancellor Michael Glass to move the funds from the sale of the St. Columba property sold earlier this year, along with the Redeemer property sold several years ago.

The proceeds of these two properties are shown on the Balance Sheet Accounts #10700 (\$452,413.33) and #10800 (\$2,842528.08). I have been working with Chancellor Michael Glass who is seeking approval from the California State Attorney General to formally dissolve these parishes so the funds can be moved into our DFMS Account #11111. This is not an easy task and relies on action from that office. We are hoping to have this completed before the end of the year and have included this expectation in the 2025 Budget.

In anticipation of the release of those funds the Diocesan Council approved a drawdown of \$200,000 which funded the much-needed Building and Grounds Grants for 2024, which several parishes were able to receive assistance for long-deferred parish maintenance. Unfortunately, the advance drawdown negatively impacted our expected interest income for the year, reducing our expected income while we wait for the release of the funds from the property sales.

Included with this report is the Portfolio Performance of the DFMS accounts through the end of August. The critical line to take note of is labeled "Portfolio Return (net)" which shows the Year-To-Date Return of 10.8%, the 1-Year Return of 16.5%, along with the 3-, 5-, and 10-year returns.

In reviewing the 2024 Budget I estimated the interest withdrawal from the DFMS #11111 Account to be 4.85% and the principal drawdown of 4.72%, resulting in a total drawdown in 2024 of 9.57%. We have been fortunate that the Stock Market has had a good run these last 2 years; it is evident we will need to reduce our dependence on the drawdown over the next few years to prepare for the next market turn.

I have come to realize that the DFMS Account #11111 is a barometer for the financial health of the Diocese, or in layman's terms, the "Goose That Laid the Golden Egg". I intend to find ways to protect our Goose! It is the challenge of our Diocese to find ways to support our ministries with the people of the Diocese of San Joaquin, without falling into a death spiral of finances, yet also without hording wealth. We are Called to Be...

Profit & Loss results first 3 quarters

While our Profit & Loss shows a net loss of \$248,027.32 for the year, nearly all of it was due to the unplanned Debt Forgiveness worked through with the Cathedral.

There were higher expenses for General Convention, but this had been allocated annually over the last 4 years. I was unable to find a list of the annually allocated funds, so decided to use Account #10400 on the Balance Sheet to set aside the annually allocated funds. As of 2024, these are: \$2,000.00 towards Lambeth Conference; \$2,000.00 towards Bishop Sabbatical; and \$19,046.50 (as of 8/31/24) remaining towards the Buildings and Grounds Grants. In the coming years the allocated funds can be transferred to this account, and as these events happen the funds can be transferred out to cover expenses, helping the budgeting and reporting processes.

Alisa Sparks, CPA, our new bookkeeper has been invaluable in streamlining our payment process and correcting some residual entries in the bookkeeping file. We have already cleared the 11001 Legal Retainer and 13000 Prepaid Expenses accounts, which had entries left open from several years ago. The 12000 Accounts Receivable account is still in need of review.

In the coming months I hope to review our bank accounts in an effort to improve our interest income from the funds in the Diocesan bank accounts. The current bank pays all of 0.02% on our bank balances.

Audit Update

The 2021 Audit was completed in June of this year. The 2022 Audit was delayed while I worked with Alisa to streamline our bookkeeping file, and the 2022 Audit has just been started with the outside CPA, with the 2023 Audit to be started quickly after this.

2025 Budget

The proposed 2025 Budget is included in this report. With the addition of new clergy at several of our parishes we have significantly raised budgeted expenditures in support of the parishes.

As parishes improve their stewardship and participation, the strain on Diocesan finances should lessen.



AUGUST 2024 PORTFOLIO PERFORMANCE

For the month of **August**, the total fund rose 2.2%, net of fees, bringing the YTD return to 10.8%.

The MSCI ACWI returned 2.5% during the month, leaving its year-to-date at 16.0%. In the US, the S&P 500 returned 2.4% during the month, and its year-to-date at 19.5%. The Russell 2500 Index fell 0.3% during the month. Overseas, the MSCI EAFE index returned 3.3% in August, with emerging market stocks returning 1.6%.

In August, equities slowed after a strong run over the past few months. The US outperformed most major developed and emerging market countries, while growth generally outperformed value. Fixed income generally showed positive returns as inflation weakened. The Bloomberg US Aggregate Index rose 1.4%.

Headline inflation ticked up slightly in the US but dropped sharply in the UK and Eurozone; but core inflation generally continued to soften for most regions. Central bankers expressed cautious optimism, while acknowledging that inflation remains elevated. The Bloomberg Aggregate index returned 1.4% during the month.

EREN Report - 2024 Update

This report for the Episcopal Renewable Energy Network (EREN) is submitted to the 65th Annual Meeting of the Diocesan Convention. It includes an overview of progress to date, updated projections, and critical organizational changes.

In early 2024, EREN lost its Executive Director and key visionary, Cal Harling. This has significantly impacted EREN and the Diocese, but despite this loss, EREN is actively pursuing new growth opportunities under the leadership of the Bishop as a board member and with assistance from the Chancellor.

Negotiations have been underway to secure new services from third-party providers, enhancing the scope of services available to dioceses and related partners. Additionally, EREN is exploring funding avenues to support these expanded offerings and ensure sustainable operations with the primary developer, who has a tested record in financing and building systems for faith-based organizations, including The Episcopal Church.

Parallel with these efforts, EREN is beginning to finalize its plans for interim and long-term leadership for the day-to-day operations of EREN.

Projections for 2025

By the end of the first quarter of 2025, EREN hopes to have finalized an MOU with a non-profit developer to provide some longer-term staffing for EREN's operations and secure alternative funding sources.

EREN anticipates securing two additional engagements in 2024 to develop solar systems and hopes to host several educational forums within The Episcopal Church and beyond. Although market engagement timelines remain extended, EREN continues cultivating relationships with Episcopal dioceses and is expanding outreach to additional denominations.

EREN is working to reducing its financial support from the Diocese by the 2026 budgeting cycle.

RESOLUTION

Title: Special Rules for the Election of a Bishop

Resolution No.: 2024-R001

Sponsor: Standing Committee **Required Vote:** Simple Majority

RESOLVED, Diocesan Canon I.1.01is deleted in its entirety and replaced with the following:

Whenever, in the Providence of God, it may be necessary to choose a Bishop, the call for such election shall be made by resolution of the Standing Committee, which shall give, through its Secretary, notice of such election to every Clergy member, Parish, and Mission of the Diocese. Following such call to election a Search Committee shall be composed by electing one (1) cleric and one (1) member of the laity from each deanery. In addition, the Ecclesiastical Authority may appoint one, three, or five members. The organization and operation of the Search Committee shall be determined by the members. The prayers of the Clergy and Laity shall be bidden, that God may supply a Pastor after His own heart.

Under Canon III.11.1.a of the Constitution and Canons of The Episcopal Church, the Standing Committee shall oversee and be responsible for the processes for the search, nomination, transition, and election of a Bishop. The Standing Committee may propose special rules of order for the consideration and adoption by the Diocesan Convention to implement its responsibility under this Canon and Canon III.11.1.a of the Constitution and Canons of The Episcopal Church.

RESOLVED, that the following Special Rules for the Election of the Bishop be adopted:

Special Rules for the Election of a Bishop

Pursuant to Diocesan Canon I.1.01, the following special rules for the election of a bishop ("Special Rules") shall govern the search, nomination, transition, and election of a Bishop. These Special Rules may be amended or suspended after their adoption by the Convention by a two-thirds majority of the certified delegates voting in each order. If the balloting has commenced for the election of a Bishop, then no Special Rule may be amended or suspended without the four-fifths vote of the certified delegates in attendance. These Special Rules shall be continuing for any future election of a Bishop, Bishop Coadjutor, or Suffragan Bishop, except that at the commencement of any future electing

convention, they may be amended or modified by a two-thirds majority of the certified delegates voting in each order.

Rule One. Standing Committee Oversight.

1.1 Upon receiving written notice of (i) the intent of the Bishop to resign, (ii) death of the Bishop, or (iii) other circumstance of vacancy, the Standing Committee shall convene within sixty (60) days to initiate the process for election of a new Bishop.

- 1.2 The Standing Committee shall have oversight and responsibility for the process of electing a Bishop as described in these Special Rules for the Election of a Bishop ("Rules") and according to Constitution Article II, and Canon Title III.11-12 of the Constitutions and Canons of The Episcopal Church ("TEC"), and the Constitution of the Episcopal Diocese of San Joaquin.
- 1.3 The Standing Committee shall have oversight and responsibility for determining the compensation package for the elected Bishop, after collaborating with the Diocesan Council to determine the budget for that expenditure.

Rule Two. Disqualifications.

- 2.1 No Standing Committee member whose name is submitted or expected to be submitted for consideration by the Nominating Committee shall thereafter participate in the Standing Committee's exercise of its responsibilities and discretion under these Rules.
- 2.2 No person whose name is submitted or is expected to be submitted for consideration by the Nomination Committee shall thereafter serve on the Nomination Committee or the Transition Committee.
- 2.3 No member of any of the foregoing Committees participating in the process governed by these Rules may be nominated under Rule Ten, without the prior express written consent of the Standing Committee.

Rule Three. Election of Bishop Coadjutor or Bishop Suffragan.

3.1 If the Convention adopts a resolution authorizing the election of a Bishop Coadjutor or, with the concurrence of the Bishop, a Bishop Suffragan, the process of selecting the nominating committee and the election of the Bishop shall commence immediately after the adoption of the resolution. The nomination and election process shall first have received the prior consents from the Bishops and Standing Committees of The Episcopal Church as required by TEC Canon III.11.10-(a)-(b).

Rule Four. Responsibilities of the Standing Committee.

In overseeing the election process, the Standing Committee shall:

- 4.I Give notice in all appropriate publications that the Diocese is entering into the process for an election into the Episcopate;
- 4.2 Establish the date for the election;
- 4.3 Form a Nominating Committee (the "Nominating Committee") and appoint its members;
- 4.4 Form a Transition Committee and appoint its members:
- 4.5 Form or retain any other committees, consultants and chaplains for the process as it deems appropriate;
- 4.6 Determine the means and procedures for nominations and amendments thereto as may be proposed by the Nominating Committee;

- 4.7 Receive the slate of proposed final nominees from the Nominating Committee, and provide for background checks on all such persons, in consultation with the Presiding Bishop's Office.
- 4.8 Collaborate with the Nominating Committee, the Transition Committee and Diocesan staff leadership to provide appropriate financial means, staff support and facilities support for the nomination process, electing convention, episcopal transition, ordination/consecration, and of the committees, the budget for which shall be subject to approval of the Diocesan Council;
- 4.9 Provide for procedural and logistical details for the Electing Convention not inconsistent with these Rules, particularly Rule Thirteen, and to oversee the election;
- 4.10 Seek the necessary TEC consents required following the election; and
- 4.11 Provide for the Ordination and consecration of the elected Bishop, in collaboration with the Office of the Presiding Bishop;
- 4.12 Provide for the seating of the elected Bishop.

Rule Five. Nominating Committee.

- 5.1 The Standing Committee membership not otherwise disqualified under Rule 2 and not less than six (6) and no more than eight (8) additional members appointed by the Standing Committee shall constitute the Nominating Committee. The membership appointed by the Standing Committee shall be equally divided between clergy and laypersons and be constituted to represent the diversity of the Diocese.
- 5.2 The Standing Committee may appoint a liaison to the Transition Committee, who shall serve as an observer and source of communication with seat and voice but no vote.
- 5.3 The meetings of the Nominating Committee shall be held in closed session, not open to the public, to preserve privacy and confidentiality.

Rule Six. Responsibilities of the Nominating Committee. The Nominating Committee shall:

- 6.1 Determine its own processes and procedures, subject to the supervision of the Standing Committee;
- 6.2 Complete a survey and publish a Diocesan Profile;
- 6.3 Organize and conduct a search for appropriate candidates;
- 6.4 Coordinate the receipt of nominations within a published timeframe for the receipt of nominations;
- 6.5 Develop a slate of proposed nominees and arrange with the Standing Committee for background checks on all persons proposed to be final nominees;

- 6.6 Provide periodic progress reports to the Diocese without violating rules of confidentiality;
- 6.7 Consult with the Office of the Presiding Bishop regarding processes required by the Presiding Bishop;
- 6.8 Present the final report of the Nominations Committee to the Standing Committee at least 90 days in advance of the Electing Convention. This report shall contain the biographical information on each nominee and any other information as appropriate.

Rule Seven. The Transition Committee.

7.1 The Standing Committee shall appoint no fewer than six (6) persons as members of a Transition Committee. The membership shall include both laypersons and clergy and shall reflect the diversity of the Diocese.

Rule Eight. Responsibilities of the Transition Committee.

The overall responsibility of the Transition Committee is to ensure the smooth transition of a newly elected bishop into the life of the Diocese and provide for the transition, including a celebration of the ministry of the retiring Bishop. The Committee shall:

- 8.1 Determine its own processes and procedures, subject to the supervision of the Standing Committee;
- 8.2 Provide an appropriate flow of information to the Diocese and to the media with
 - regard to the transition by utilizing all communication means available within the diocesan structure;
- 8.3 Provide support to the incumbent Bishop and Diocesan staff;
- 8.4 Provide for an opportunity for all nominees to meet with as many members of the Diocese as possible, in creative ways including, but not limited to, a "walk-about";
- 8.5 Plan and direct the Ordination, consecration and seating of the new Bishop, in consultation with the Standing Committee and Presiding Bishop of TEC;
- 8.6 Assist the Bishop-elect in adapting to and being introduced to the diocesan community;
- 8.7 Provide for the transition of the retired and/or resigned Bishop from office, including a formal recognition and celebration of the Bishop's ministry; and
- 8.8 Provide a written report to the Standing Committee upon completion of the process.

Rule Nine. Nominees.

9.1 Not fewer than ninety (90) days prior to the designated date for the electing convention, the Standing Committee shall receive the report of recommended nominations from the Nominating Committee, verify the eligibility and background check completions on each nominee and proceed to announce publicly the names of those nominated in all appropriate publications.

Rule Ten. Supplemental Nominations.

- 10.1 Supplemental nominations may be made by petition submitted to the Standing Committee for a period of five (5) days following the public announcement of the list of nominees.
- 10.2 In order to be considered, each supplemental petition must be signed by at least three (3) Clergy from at least three (3) different congregations and (3) lay persons from at least three (3) different congregations within the Diocese and must be accompanied by all information required of other candidates by the Standing Committee.
- 10.3 Upon receipt of one or more properly prepared petitions, the Standing Committee shall secure the required background checks for each person nominated by supplemental petition.
- 10.4 Once the deadline has passed and the background checks have been approved, the Standing Committee shall announce the names of the approved nominees in all appropriate publications and send separate written information concerning the supplemental nominees to all Clergy and Lay Delegates as soon as practicable, at which time the nominations shall be deemed closed.
- 10.5 The final slate of nominees introduced to the Diocese shall consist of Nominees recommended by the Nominating Committee and those properly made by supplemental petition.

Rule Eleven. Nominations During Convention.

11.1 The Standing Committee will place in nomination the names of all persons whose names were submitted to it by the Nominations Committee, and also those who have fulfilled the petition requirements. No nominations from the floor shall be permitted.

Rule Twelve. Budget.

The Diocesan Council shall be responsible to:

- 12.1 Collaborate with the Standing Committee to establish a budget for the compensation package for the elected Bishop;
- 12.2 Provide a budget sufficient to fund the work of the Nomination Committee as described in this canon; and
- 12.3 Provide a budget sufficient to fund the work of the Transition Committee as described in this canon.

Rule Thirteen. Electing Convention.

13.1 Decorum.

(a) The floor shall be restricted to those holding delegate credentials by the Credentials Committee. Prior to the commencement of the voting on each ballot the Chair shall assure itself that only delegates are on the floor except for those

which the Chair shall have otherwise permitted. The ballots shall thereafter be distributed.

- (b) No nominee, if a delegate, may be a member of the Committees on Credentials, Dispatch of Business, involved with the collection or counting of ballots, speak to the convention as to the nominee's candidacy, or withdrawal from the same, or announce to the convention assembled after withdrawal, support of any other nominee.
- (c) It shall be deemed inappropriate for presentations on the floor by any delegate beyond the nomination process.

EXPLANATION:

The proposed canonical amendment and special rules will bring the Diocesan Canons and the process of discerning and electing a bishop up to date and aligned with the best practices and Canons of The Episcopal Church.

FISCAL IMPACT:

These changes are not expected to impact the existing budget line items currently in the Diocesan Budget for the discernment and election of a bishop.

Resolutions from the 81st General Convention requiring Constitutional Changes or Alteration of the Book of Common Prayer

It is a requirement of Canon I.1.1.e that all Dioceses receive notice whenever any alteration of the Book of Common Prayer or of the Constitution is proposed. The 81st General Convention proposed two resolutions with changes to the Constitution of The Episcopal Church and one with changes to the Book of Common Prayer. It is the duty of each Diocese to make known such proposed alterations to their Diocesan Convention and to certify to The Episcopal Church that such action has been taken. The entire text of each of the three resolutions is listed below for your examination.

Resolution A116 Marriage Rites for Inclusion in the Book of Common Prayer (First Reading)

Resolved, That the 81st General Convention authorize for trial use under Article X.b the following revisions to the Book of Common Prayer 1979:

BCP pp. 349 and 381: Following the Preface of Marriage, add the rubric "or this", followed by Preface of Marriage, Standing Commission on Liturgy and Music (SCLM) Blue Book report p. 39

BCP p. 423: Revise the title to read "The Celebration and Blessing of a Marriage I"

BCP p. 433: Revise the title to read "The Blessing of a Civil Marriage I"

BCP p. 435: Revise the title to read "An Order for Marriage I"

Following BCP p. 438, add The Celebration and Blessing of a Marriage, SCLM Blue Book report pp. 28-36; The Blessing of Civil Marriage, SCLM Blue Book report pp. 36-37; An Order of Marriage, SCLM Blue Book report pp. 37-38; and Additional Directions, SCLM Blue Book Report, pp. 38-39; with the following revisions:

SCLM Blue Book Report p. 28: Revise the first paragraph Concerning the Service as follows: "At least one of the parties must be a baptized Christian; the ceremony must be attested by at least two witnesses; and the marriage must conform to the laws of the State and the canons of this Church."

SCLM Blue Book Report p. 29: Revise the title to read "The Celebration and Blessing of a Marriage II"

SCLM Blue Book Report p. 35: Replace "Preface of the Season" with "Preface of Marriage, or of the Season"

SCLM Blue Book Report p. 36: Revise the title to read "The Blessing of a Civil Marriage II"

SCLM Blue Book Report p. 37: Revise the title to read "An Order for Marriage II"

SCLM Blue Book Report p. 37: Replace the first paragraph of An Order of Marriage with the following text: "If it is desired to celebrate a marriage otherwise than as provided in the Book of Common Prayer or any authorized alternative thereto, this Order is used."

SCLM Blue Book Report p. 37: Revise paragraph 3 of An Order of Marriage as follows: "The laws of the State and the canons of this Church having been complied with, the couple, together with their witnesses, families, and friends assemble in the church or in some other convenient place."

Blue Book Report p. 37: Revise #1 of An Order of Marriage as follows: "The teaching of the Church concerning Holy Matrimony, as it is declared in the formularies and canons of this Church, is briefly stated."

And be it further

Resolved, That these liturgies authorized for trial use be made available electronically at no cost; and be it further

Resolved, That the Standing Commission on Liturgy and Music be directed to engage a dynamic equivalence translation of these texts into the Spanish, French, and Kreyol languages; and be it further

Resolved, That the liturgies The Celebration and Blessing of a Marriage, The Blessing of a Civil Marriage, and An Order for Marriage as authorized in The Book of Common Prayer 1979 continue to be authorized for use in all dioceses of The Episcopal Church; and be it further

Resolved, That the General Convention request the Executive Council Budget Committee to allocate \$12,000 for translation.

Resolution A043 Amend Constitution Article VIII regarding Clergy in Local Ecumenical Partnerships - [First Reading]

Resolved, That the 81st General Convention amend Article VIII of the Constitution by adding the following paragraph at the end of the existing article:

The Book of Common Prayer in this Church is intended to be communal and devotional prayer enriched by our church's cultural, geographical, and linguistic contexts. The Book of Common Prayer shall contain both public worship and private devotion.

The Book of Common Prayer, as now established or hereafter amended by the General Convention, shall be in use in all the Dioceses of this Church.

Sec. 2. No alteration thereof or addition thereto shall be made unless the General Convention approve the same on first reading in one regular meeting of the General Convention and, by resolve so directing, be sent by the Secretary of the General Convention to the Secretary of the Convention of every Diocese, to be made known to the Diocesan-Convention at its next regular meeting, and be adopted on second reading without alteration by the General

Convention at its next succeeding regular meeting by a majority of all Bishops, excluding retired Bishops not present, of the whole number of Bishops entitled to vote in the House of Bishops, and by an affirmative vote by orders in the House of Deputies in accordance with Art. I, Sec. 5 of this Constitution, except that concurrence in the affirmative by the orders shall require the affirmative vote in each order by a majority of the Dioceses entitled to representation in the House of Deputies.

Reports to Diocesan Convention

Standing Committee Report 2023-2024

The Canons of the Episcopal Church charge each Diocese at their respective Conventions to elect a body called a Standing Committee. The Constitution and Canons of this Diocese charge each convention to elect one lay and one clergy person to membership of this Committee, thus creating a body of eight members, each person serving a four year term.

The present members of the Standing Committee include:

Rev. Suzy Ward – Priest-in-charge, St. Paul's, Visalia

Linda Masztal – St. Paul's, Modesto
Cindy Smith – St. Paul's, Bakersfield

The role of the Standing Committee is of course to serve as Bishop David's council of advice. This Committee meets monthly by zoom. Every other month the Standing Committee meets jointly with Diocesan Council, but even after the joint meeting, the Standing Committee meets to consider its own business. Generally, such business would include discussion and voting to consent to the election of a bishop from another Diocese. Every diocese of the Church is expected to provide an up or down vote for consenting to the election of Bishops. This year the EDSJ Standing Committee consented to the election of five individuals to become a Bishop. This included the Diocese of Massachusetts, the Diocese of Olympia, the Diocese of Rochester, the Diocese of Mississippi, and the Diocese of California.

When a Bishop announces their retirement, it is the Standing Committee that is charged with creating a Nominating Committee. This is the role that the EDSJ Standing Committee is currently serving. The Standing Committee, in its role as Nominating Committee, has begun the process of developing a profile, a narrative description of the diocese as well the diocesan vision for the future. This work is accomplished through the diocesan wide survey and the listening sessions that just concluded.

The Standing Committee, with the budget support of the Diocesan Council, has hired a consultant to assist the Nominating Committee in insuring the fulfillment of all the canonical requirements and the best practices for the election of a new bishop. Brian Nordwick, is a retired deacon from the Diocese of El Camino Real. He has served as a consultant to many dioceses of the church. Most recently he served the Diocese of New Jersey.

The work of the Diocesan Standing Committee is critical in its support of the ecclesiastical authority of the Diocese. It is truly a Godly service that involves listening, patience, and prayerful discernment for the benefit of all the people of the Diocese in support of the wisdom of the Bishop.

Diocesan Council 2024

The Diocesan Council performed its duties and responsibilities according to the Canons and Constitution of the Episcopal Diocese of San Joaquin during the term following the 64th Annual Meeting of the Convention by:

- --Meeting monthly, via ZOOM web/teleconference or in person, in accordance with requirements and procedures specified by Canon 9.05.
- --Receiving monthly reports from The Right Rev Bishop David Rice regarding his leadership and ministry in the Diocese and the wider Church.
- --Receiving monthly reports from The Rev Canon Anna Carmichael regarding the status and activities with Diocesan transitions in progress, the work of Diocesan Commissions, and other ministries and projects.
- --Receiving monthly reports from Chancellor Michael Glass regarding the status of Diocesan property sales and support, litigation, congregation support, and governance updates.
- --Receiving monthly reports from ECCO Directors, Joanne Kovac-Roberts & Michael Roberts regarding the status of ECCO's buildings, grounds, and equipment as well as scheduled events and activities.
- --Reviewing and approving financial reporting submitted monthly by Treasurer Deacon Greg Masztal regarding Diocesan operating income and expense in relation to budget requirements and the status of Diocesan investments managed by DFMS (Domestic & Foreign Missionary Society).
- --Reviewing the status of assessment payments pursuant to Diocesan Canon 21.10
- --Electing Jan Dunlap as Vice President and The Rev Dcn. Terry March as Secretary of Diocesan Council.
- --Approving the submitted Housing Allowance resolution for diocesan-paid clergy (Bishop, Canon, and Latino Missioner) to designate part of their salary to be tax-free for housing in lieu of being provided a rectory.
- --Approving the Purchase and Sale Agreement pursuant to Diocesan Canons 25.03 and 25.04; dated November 13, 2023 for the final sale of property located at 498 North Valencia Blvd., City of Woodlake, CA for the selling price of \$420,000.00.
- --Approving the transfer of the bequest received by St. Anne's, Stockton from the Martha Janice Mallery Trust to an investment account titled the "Mallery Bequest Fund" with the Domestic and Foreign Mission Society of The Episcopal Church ("DFMS") with the corporation sole as the account holder in accordance with Diocesan Canon 25.02; and that pursuant to Diocesan Canon 25.05 the Parish receive a one-time distribution of principal of the fund in the amount of \$20,870 for the repairs to its stain glass windows.
- --Directing the treasurer to use \$750.00 of the unused and available funds set aside for Hanford's clergy compensation to fund the cost of showing the documentary on the Philadelphia 11.
- --Approving a COLA increase of 5% for the Cathedral Curate and directing the treasurer to use \$2,827 of the unused and available funds set aside for Hanford's clergy compensation to fund the increase.
- --Endorsing Canon Anna's proposed sabbatical plans to take her long overdue sabbatical and divide the scheduled time off in two parts. The first part taking off the month of August 2024 to go back to South Africa for a seminar, independent study, and a trip to Johannesburg. The second part taking

time in March/April 2025 to walk a part of the Camino using the remaining time for a RV national park circle of Colorado, Utah, Nevada and Arizona, spending time reflecting and refreshing.

- --Confirming the appointment of the Rev. Dcn. Greg Masztal as Diocesan Treasurer and authorizing his name be added as signatory to manage all diocesan accounts.
- --Approving the addition of Suzy Ward, Standing Committee President and Jan Dunlap, Diocesan Council Vice President as signatories on diocesan bank accounts to facilitate providing two signatures when required.
- --Approving quarterly withdrawals from DFMS investment accounts of \$189,926.05 totaling an annual withdrawal of \$759,705 as part of the budgeted income to fund Diocesan operations.
- --Approving the Purchase and Sale Agreement pursuant to Diocesan Canons 25.03 and 25.04; dated February 1, 2024 for the sale of property located at 5073 N. Palm Ave, Fresno, CA for the selling price of \$3,000,000.00
- --Approving the reallocation of \$10,000 from the budget line item for Episcopal Church of the Saviour (ECOS) clergy support grant to cover costs of Religious Worker Visas (R1Visas) for the two new clergy called to Modesto and Sonora / San Andreas
- --Approving designating and setting aside \$200,000 of the proceeds from the sale of St. Columba (5073 N. Palm Ave, Fresno, CA) for the establishment and funding of a 2024 Buildings and Grounds Grant to allow for 10 congregations to apply for up to \$20,000 each. Faith communities awarded grants in 2024 will not be eligible to apply for a grant in 2025 however can again apply in 2026.
- --Approving the use of the Buildings and Grounds Grant Application and Reporting forms developed by the Diocesan Office.
- --Approving the drawdown of \$200,000 to fund the Buildings & Grounds Grants with the understanding that the funds will be restored once the Attorney General approves the dissolution of St Colombia corporation; allowing for the funding of the Building & Grounds Grants as an interim funding solution after encountering delays from the CA Attorney General's office.
- --Authorizing Chancellor Mike Glass to issue a non-binding letter of intent for the sale of five acres of unimproved acreage at St. John's Lodi to the Bank of Stockton with a purchase price of \$900,000, which will include a refinancing of the existing debt against the property
- --Accepting the use and distribution of the Repudiating the Doctrine of Discovery Toolkit as prepared by the Anti-Racism Commission, SJRAISE, and Creation Care Commission
- --Approving a Memorandum of Understanding with St. James' Cathedral and authorizing the President and Vice President of the Diocesan Council to execute the MOU. The MOU specifying:
 - --Forgiveness of a portion of the outstanding debt incurred by St. James' Cathedral with the Diocese in the amount of \$240,127.97.
 - --Forgiveness is conditional upon payment of all past due Assessments on or before May 1, 2024 with the prompt submittal of all TMRs and payment of future assessments; partial payment of the Outstanding Debt in the amount of \$35,759.28, in 24 monthly installments of \$1,489.97 commencing on June 1, 2024, due on the first of each month; adjust the current Cathedral Budget for the fiscal year 2024 to provide for the provision of a full time Dean.
 - --Through December 31 2024, the Cathedral Chapter will continue to invite Diocesan Council representatives (currently Diocesan Council members Jan Dunlap and Stephanie Gilmer) to attend each meeting of Chapter with voice and seat and receive all notices, documents, financials, budgets, minutes, and agendas
 - --The Cathedral shall continue with the completion of audits through the fiscal year 2023 in a timely manner with the scope and nature of the audit for 2022 and 2023 agreed upon by the Cathedral Treasurer, Diocesan Treasurer and the Bishop in consultation with the Diocesan

Chancellor

- --To date (October 1, 2024) the Chapter Cathedral has worked diligently toward meeting the conditions of the MOU. The 2024 proposed Cathedral budget relied on income from the rental of Cathedral property. Those rentals have not yet materialized and as a result the Diocese recognized the need to temporarily fund the Cathedral Dean's position by including a six-month salary and benefits designation in the Diocesan 2025 Budget submittal.
- --Recognizing the resignation of Nichole Pardo, Diocesan Administrator with appreciation and thanks for Nichole's contribution to the Diocese and direct support of the Diocesan Council.
- --Approving reallocation of funds designated for the Diocesan Administrator's salary and benefits for the portion that will be required to compensate Padre Jorge Pallares, St. Michael's, Ridgecrest for full-time ministry for the remainder of this year. Due to a requirement by Church Pension Fund for retired clergy, Fr. Jorge must return to full time ministry after serving for two years in order to remain at St. Michael's, Ridgecrest.
- --Approving the expenditure of not to exceed \$24,000.00 for to conduct the 2022 audit with DeMera DeMera Cameron, using funds that are available within our current 2024 budget.
- --Approving an expenditure not to exceed \$3,000.00 to finance the Kaleidoscope anti-bias training expenses for the Standing Committee as part of the Bishop search process using funds that are available within our current budget
- --Submitting the proposed 2025 Diocesan Budget for consideration and approval by the 65th Annual Convention in accordance with the requirements of Canon 9.06.

The Diocesan Council would like to recognize and thank Treasurer Deacon Greg Masztal for his financial reporting and guidance and the many hours of effort that they represent, Chancellor Mike Glass for his guidance and expertise, Canon Anna Carmichael for preparing and distributing supporting documentation and meeting logistics along with her support and expertise, and Bishop David Rice for his leadership and direction.

Commission on Ministry Report 2024

The Commission on Ministry (COM) of the Diocese of San Joaquin is established in accordance with the canons of the Episcopal Church in the United States, "In each Diocese there shall be a Commission on Ministry consisting of Clergy and Lay Persons" (Title III, canon 2) and Canons of the Diocese of California (canon XIV). The work of the Commission on Ministry is concerned with the discernment and call to ministry of all baptized persons. A primary focus is guiding and examining aspirants, postulants, and candidates in their discernment process for Holy Orders as well as making its recommendations to the Bishop and Standing Committee.

The Commission is currently comprised of Ms. Laurelee Brown, Ms. Melissa Crider, Ms. Candice Gale, The Rev'd Lisa Jacoby, The Rev'd Cathy Kline (clerk), The Rev'd Luke Martinez, The Rev'd Greg Masztal, Mr. William Patterson, The Rev'd Luis Rodriguez (chair), Ms. Nancy Silva, Dr. Barbara Vassell, The Rev'd Bob Woods.

Since the last Diocesan Convention, the Commission has gathered six times; twice in-person and four times via Zoom. This first in-person meeting (February 27) was a work day and orientation for members to get to know each other and the work of COM. The second in-person meeting was a work weekend and retreat at ECCO when the Bishop met with us on the first evening. During its time together, the members discussed the work of the Commission of Ministry, as well as the discernment and training process for all ministers, lay and ordained. Recommendations were sent to the Bishop in the form of a letter.

At its May meeting the Commission met with three aspirants for a "meet and greet", and with one aspirant in August. All have been assigned shepherds. Only three have continued in discernment.

Two Eucharistic Minister training sessions were offered by COM. One in March at St. Anne's, Stockton (for the Northern Deanery), and on in August at St. Paul's, Bakersfield (for the Central and Southern Deaneries). From these two trainings, 22 people were licensed to serve in parishes throughout the diocese.

In September, the Commission hosted a Day of Discernment for those exploring their vocation, lay ordained. It was attended but five COM members and by two enquirers.

Although not all the plans predicted for the present year came to fruition, while some which were not planned, – for example, the COM weekend – bore much fruit. Indeed, it was unanimous among members that the weekend should be an annual event. Plans continue for more intentional and expansive provision for lay ministry, including Eucharistic Visitor Training which is sadly lacking.

There is currently one postulant in the discernment process and engaged in seminary education with CDSP.

As the year comes to a close, a number of members will be stepping down from the Commission having served full terms, namely The Rev'd Cathy Kline, The Rev'd Luis Rodriguez, and The Rev'd Greg Masztal. We are indebted to them for all their work on behalf of the Diocese and the Church.

Audit Committee (Congregational Management Review) 2024

This year parishes were to complete their Congregational Management Reviews (CMRs) reflective of the 2023 fiscal year. The CMRs include both a financial review, as well as a review of Vestry/BC/Chapter minutes, operational protocols, and disaster preparedness plans. Completion of the CMR is a requirement of the Canons of The Episcopal Church, which mandates that every congregation is to have an annual financial audit.

As approved by Diocesan Council in 2022, congregations continue to use the CMR format in a 3-year rotation.

Year 1—internal CMR done by members of the congregation, but not the Treasurer or Clergy person responsible for the congregation

Year 2—peer CMR done by a neighboring congregation

Year 3—independent CMR done by a member of the Audit Committee

The Diocesan Council continued with the policy allowing for members of the Audit Committee who conduct independent CMRs to be compensated in the amount of \$500, which is much less than having a Certified Public Accountant perform the audit.

Buildings & Grounds Grants, 2024

This year the Finance Committee, made up of Ms. Stephanie Gilmer (Diocesan Council), Deacon Teri VanHuss (chair, CMR committee), and Deacon Greg Masztal (Diocesan Treasurer) were tasked to review applications from eligible congregations applying for the inaugural Buildings & Grounds Grants. Canon Anna Carmichael was asked to create an application and reporting form for congregations to use. Canon Anna served as the liaison between the Finance Committee, the congregations and the bookkeeper to ensure that the flow of information and funding was accurate. These grants were made available by Diocesan Council following the sale of the St. Columba property. Prior to investing the sale funds with the Domestic & Foreign Missionary Society (DFMS), Diocesan Council approved to make \$200,000 available in grants for deferred maintenance projects in congregations around the diocese.

To be eligible to apply for a Buildings & Grounds grant, congregations had to meet the following requirements:

- 1. Approval of Chapter/Vestry/BC to apply for grant
- 2. Bids for work to be done
- 3. Up to date on diocesan assessment

The following congregations submitted Buildings & Grounds grant applications and were awarded:

- St Andrew's, Taft (building repair and repaint)
- St Michael's Ridgecrest (replacement of electrical panel)
- St John's, Tulare (replacement of roof)
- St Paul's Visalia (replacement of flooring in the parish hall)
- Episcopal Church of the Saviour Hanford (replacement of flooring)
- St Paul's Modesto (replacement of roof)
- St John's Stockton (replacement of security lights, fencing)
- St Anne's Stockton (upgrading of electrical system, painting, ground maintenance)
- St John's Lodi (backflow system repair)
- St Clare's Avery (resurfacing of parking lot and making ADA improvements)

A total of \$191,422.56 was allocated to congregations in 2024.

Latino Missioner Report

Since the last Diocesan Convention, there has been much progress in the Ministerial Development activities related to the Office of Hispanic Ministries.

In the parishes of The Cathedral, San Francisco in Turlock, and San Pablo in Bakersfield, we held the Posadas celebration, thanks to the support of SJRAISE. It was an excellent opportunity for the deaneries to meet, learn, share Mexican culture, and celebrate Christmas. This year, 2024, we have planned three Posadas celebrations per deanery, which will be held in the Parishes of Lodi (December 14), Bakersfield (December 16), and Fresno (December 18). We are in contact with the clergy of the different deaneries to support these celebrations.

Thanks to the recommendation of Father Anthony Guillén, we applied for a scholarship for the Congregational Development of the Latino Community of our Cathedral through the Calvin Institute for Christian Worship. The project planning and implementation team proposed to focus the project and the nearly \$15,000 allocated to strengthening the congregation's leadership through the training of lay leaders in the following areas: music, liturgy (proclamation of the Word of God and presiding over Morning Prayer and Preaching), altar service, and the creation of liturgical art. The development of this project strengthened the leadership of some people in the community, who are now trained to lead prayer (morning or evening) without a presiding priest.

As part of the grant, guitar and percussion classes and singing classes were offered to some parishioners. The congregation's music quality has improved substantially, and we now have some children exploring their musical abilities. The Spanish-speaking congregation's choir has joined the English-speaking choir in some of the liturgical celebrations throughout the year, and joint work is planned for the celebration of Christmas 2024.

With the support of Deacon Nancy Key, we applied for a grant through the Episcopal Evangelism Society to develop our ministry with agricultural workers. The grant of \$5,000 was approved. A portion of the money was disbursed at the beginning of the year, and in this second part of the year, a report of the visits and material created will be presented to proceed with the second disbursement.

Concerning the project's development, a team of non-profit organizations has been organized, with which we are planning the visits; they will go with us to the field to offer their resources and information. We have planned activities until February, one visit per month. So far, five field visits have been made, the logo for the Agricultural Workers Ministry of our Diocese has been developed, and essential materials have been ordered: a tent, table, chairs, and tablecloth. We are working on organizing material on migration, institutions that farmers can turn to if they need help, and a list of our parishes throughout the Diocese that they can go to so that we can print and distribute during our visits. We have included some flyers on the LGBTQ population in the Church for visits near the cathedral so that those who are part of the

LGBTQ population know of our support and welcome to the sexually diverse population.

In June, 6 lay people and four clergy from our Diocese attended the Episcopal Church's Hispanic Ministry Conference, Nuevo Amanecer. The presence of our Bishop as the leader of our representation was fundamental, even more so since he was the only Bishop present and one of the two main

presenters. In this presentation by our Bishop, in the presentation that Canon Anna and I gave three times, and especially with our presence at this conference, we spoke about how our Diocese is no longer invisible to the Episcopal Church, but also about how in our Diocese the voices that were not present before, women and the LGBTQ population in ministry, people of color and migrants, are now present and speaking; we are no longer invisible.

In August, we offered our second Hispanic ministry retreat. Canon Anna, Father Jorge, and Father Toni offered incredible presentations on the Spirituality of the Latin American People, Church Planting, and the identity and ethnic formation of the Latino People. Ashley McLamore also accompanied us, offering her training on power dynamics and the intersectionality that occurs with the issue of race, origin, sexual orientation, or gender identity in our communities. This experience was also significant because we had clergy in charge of Hispanic Ministry in other Dioceses participating in this meeting and learning from our experiences: Bishop Naudal Alves of the Diocese of Los Angeles and the Rev. Valori Mulvey of the Diocese of Missouri.

At the moment, we are in conversations with the Anglican Diocese of Cuernavaca to offer a Spanish immersion course in one or two years for people in our Diocese interested in receiving this training and exploring, with the help of our Hispanic Ministries office, the possibility of starting a Hispanic community in their particular context. We are also organizing two work teams to begin planting Hispanic communities in our churches: Taft and Tulare.

Desde la anterior Convención Diocesana se han dado muchos avances en el Desarrollo Ministerial de actividades relacionadas con la Oficina de Ministerios Hispanos.

En las parroquias de La Catedral, San Francisco en Turlock, y San Pablo en Bakersfield, realizamos la celebración de las Posadas, gracias al apoyo de SJRAISE. Fue una gran oportunidad de encuentro de los deanatos, aprendiendo y compartiendo la cultura mexicana y celebrando la Navidad. Este año, 2024, tenemos planeadas tres celebraciones de las Posadas por deanato, que se realizarán en las Parroquias de: Lodi (Diciembre 14), Bakersfield (16 de Diciembre) y Fresno (Diciembre 18). Estamos en contacto con los clérigos de los diferentes deanatos para apoyar estas celebraciones.

Gracias a la recomendación del Padre Anthony Guillén, aplicamos a una beca para el Desarrollo Congregacional de la Comunidad Latina de nuestra Catedral, a través de Calvin Institute for Christian Worship. El equipo de planeación e implementación del proyecto, propuso centrar el proyecto y los casi \$15.000 asignados, al fortalecimiento del liderazgo de la

congregación, a través de la formación de líderes laicos en las siguientes áreas: Música, liturgia (proclamación de la Palabra de Dios y Presidencia de Oración Matutina y Predicación), servicio del altar, y confección de arte litúrgico. El desarrollo de este proyecto fortaleció el liderazgo de algunas personas en la comunidad que cuentan ahora con capacitación para dirigir la oración (matutina o vespertina) en ausencia de un Presbítero presidiendo la celebración.

Como parte de la beca, se ofrecieron clases de guitarra y percusión para algunos feligreses, a la vez que clases de canto. La calidad de la música en la congregación ha mejorado de forma substancial, y tenemos ahora algunos niños explorando sus habilidades musicales. El coro de la congregación de habla hispana, se ha unido al coro de habla inglesa en algunas de las celebraciones litúrgicas a lo largo del año, y se prevé trabajo conjunto para la celebración de Navidad 2024.

Con el apoyo de la Diácono Nancy Key, aplicamos a una beca para el desarrollo de nuestro Ministerio con los Trabajadores Agrícolas, a través de Episcopal Evangelism Society. La beca por 5000 dólares fue aprobada. El desembolso de una porción del dinero se realizó a inicio de año, y en esta segunda parte del año se presentará un informe de las visitas y material creado para proceder al segundo desembolso.

Con respecto al desarrollo del proyecto de ha organizado un equipo de organizaciones sin ánimo de lucro, con las cuales estamos planeando las visitas; ellas irán con nosotros al campo a ofrecer sus recursos e información. Tenemos planeadas actividades hasta el mes de Febrero, una visita al mes. Hasta este momento se han realizado 5 visitas al campo, se ha desarrollado el logo del Ministerio de Trabajadores Agrícolas de Nuestra Diócesis, y se ha ordenado el material básico: Tienda, mesa, sillas y mantel. Estamos trabajando en la organización de material sobre migración, instituciones a las que los campesinos pueden recurrir si requieren ayuda, y una lista de nuestras parroquias a lo largo de la Diócesis a las cuales pueden acudir, para que podamos imprimir y distribuir en nuestras visitas. Hemos incluido para las visitas cercanas a la Catedral algunos volantes sobre población LGBTQ en la Iglesia, para que quienes sean parte de la Población LGBTQ sepan de nuestro apoyo y acogida a la población sexualmente diversa.

En el mes de Junio, un grupo de 6 Laicos y 4 clérigos de nuestra Diócesis, asistimos a la Conferencia de Ministerio Hispano de la Iglesia Episcopal, Nuevo Amanecer. La presencia de nuestro Obispo como líder de nuestra representación fue fundamental, tanto más cuanto fue el único Obispo presente, y uno de los dos presentadores principales. En esta presentación de nuestro Obispo, en la presentación que ofrecimos 3 veces Canon Anna y yo, y sobre todo con nuestra presencia en esta conferencia, hablamos de como nuestra Diócesis ya no es invisible para la Iglesia Episcopal, pero también de como en nuestra Diócesis las voces que antes no estaban presentes, mujeres y población LGBTQ en el ministerio, personas de color y migrantes, ahora estamos presentes y hablamos; ya no somos invisibles.

En el mes de Agosto, ofrecimos nuestro segundo retiro de ministerio hispano. Canon Anna, Padre Jorge y Padre Toni, ofrecieron increíbles presentaciones sobre la Espiritualidad del

Pueblo latinoamericano, la plantación de Iglesias, y la identidad y formación étnica de los Pueblos Latinos. Ashley McLamore, también nos acompañó ofreciendo su entrenamiento sobre las dinámicas de poder, y la interseccionalidad que se da con el tema de raza, origen, orientación sexual o identidad de género en nuestras comunidades. Esta experiencia fue importante también porque tuvimos clérigos encargados de Ministerio Hispano en otras Diócesis participando en este encuentro y aprendiendo de nuestras experiencias: El Obispo Naudal Alves de la Diócesis de Los Ángeles, y la Rvda. Valori Mulvey de la Diócesis de Missouri.

Por el momento estamos en Conversaciones con la Diócesis Anglicana de Cuernavaca, para ofrecer en uno o dos años un curso de inmersión en Español para las personas de nuestra Diócesis interesadas en recibir esta formación y explorar de la mano de nuestra oficina de Ministerios Hispanos la posibilidad de iniciar una comunidad Hispana en su contexto particular. Al momento estamos también organizando dos equipos de trabajo para iniciar el trabajo de plantación de comunidades hispanas en dos de nuestras Iglesias: Taft y Tulare.

Report from the Canon to the Ordinary

Greetings EDSJ! This year, 2024, has proven to be a stunning year for my office as your Canon to the Ordinary and Transition Officer.

This year I served four (4) congregations on Sundays to provide Eucharist and support to their BC/Vestries. These four congregations were: Episcopal Church of the Saviour, Hanford (1st Sunday), St John's Stockton (2nd Sunday), St Matthews San Andreas (3rd Sunday) and St James Sonora (4th Sunday).

This year I also served as co-chair to the Anti-Racism Commission along with Deacon Steve Bentley, and SJRAISE along with Jonathan Partridge. Next year I will step down from being co-chair of these commissions as other members have been raised up to fill those roles; Dr. Barbara Vassell will co-chair the Anti-Racism Commission, and Ms. Emily Burnias will co-chair SJRAISE. I will shift into the role of being Diocesan Liaison and Resource person.

Also this year, I, along with other women leaders in the diocese (Skylar Carlson, Charlene Martin, Candice Gale, and Joanne Kovac-Roberts) hosted the 3rd annual Women's Retreat "Hangin' with Mary" at ECCO. And in November of this year, I will be the facilitator of our winter clergy conference "Mary: Mother, Sister, Prophetess".

At the 2023 Diocesan Convention, I shared with EDSJ the "Tutu Desk Campaign" and issued the challenge for every congregation to support this campaign by contributing \$100 each. To my great joy and delight, EDSJ exceeded my expectations! We raised \$5,500 during the year, and in August of this year, when I took the first part of my sabbatical to South Africa, I was able to meet with Tandeka Tutu (the Arch's daughter who has taken over this project) and the CEO of the Tutu Desk Campaign non-profit to discuss design and distribution of the desks. Given that their school system is on a different schedule, our desks will be distributed in January 2025. My dream and hope is to restart the campaign again at the 2025 Diocesan Convention.

As your Transition Officer, I hosted the Province VIII Canons/Transition Officer's Conference at ECCO in March. This was a very exciting moment for me as most of my colleagues have never been to ECCO or EDSJ since the "great disruption". Our tradition is that the host offers gift bags & a taste of local goodies, so EDSJ's gift bags included pins from the Red Church, reusable straws, pistachios and almonds, a wine tasting after dinner one night featuring Lodi wines, and a trip to Yosemite during one of our afternoon breaks.

I also worked with St Paul's Modesto and St James Sonora & St Matthews San Andreas during the interview and call process for our two newest clergy, The Rev. Brian Dawson and The Rev. Karen Matthews. Both come to us from New Zealand, and we are grateful for their presence with us. As a result of their arrival, as well as Rev. Luke Martinez serving as "Assisting Clergy" at Church of the Saviour, Hanford, my Sunday service schedule shifted after my return from South Africa. Presently I am serving St James Cathedral on the 1st and 3rd

Sundays, and St John's Stockton on the 2nd Sunday of each month. The fourth Sunday is reserved for sabbath rest or if, in a pinch, I'm called to serve somewhere in need.

June was quite a busy month for my office as well. Early in the month I attended my third (3rd) Nuevo

Amanecer Latino Ministries conference, and then served as a 4th-time Deputy to General Convention at the end of the month. These are wonderful opportunities for me to learn more about the polity and structures of our church, the growing needs and presence of Latinos in The Episcopal Church, and to network with others who feel called to be a part of The Episcopal Church at large.

I am truly grateful and honored to serve as your Canon to the Ordinary and Transition Officer. I have been overwhelmed by your support for our commissions, the Tutu Desk Campaign, and my sabbatical opportunities. I will take "part 2" of my sabbatical in March & April of 2025, which will include a road trip of 12 western National Parks, and then a trip to Southern France for a Black Madonna Pilgrimage, which will end after journeying a portion of the Camino de Santiago in Spain and spending Holy Week and Easter in Madrid with a dear friend I was ordained with. I look forward to sharing stories and photos with all of you during my travels via social media.

Commission Reports

SJRAISE 2024

SJRAISE (San Joaquin Refugee and Immigrant Support and Empowerment) was on the move this year, whether writing cards of encouragement to immigrant detainees, advocating for farmworkers, or registering new Americans to vote. As we took our work outside the walls of our parishes, our diocesan immigration commission experienced the thrill of encountering Christ amidst the foreigners we met along the highways and byways of our local communities.

As in years past, SJRAISE continued our advocacy for immigrants in detention, particularly for those residing within our diocese at the Golden State Annex in McFarland and Mesa Verde Detention Center in Bakersfield. People held in these privately run centers have noted deplorable conditions, including moldy showers, partially cooked meals, extremely low pay for forced labor, and prohibitions on phone calls to friends and relatives. This year, we began a diocesan-wide campaign to write cards to detainees in these facilities, sharing the love of Christ with our immigrant siblings and letting know they were not alone. Various congregations took turns writing cards during different holidays. We received positive feedback from KWESI (Kern Welcoming and Extending Solidarity to Immigrants), which helped us coordinate the campaign, as well as the immigrants who received the cards.

SJRAISE also sponsored a table at a fundraising event for KWESI hosted by St. Paul's, Bakersfield in August, helping the organization raise nearly \$7,000 for phone calls and travel assistance for immigrant detainees. Event attendees also learned about the worldwide refugee crisis from guest speaker Pastor Eric Shafer of Global Refuge. The following month, the Bakersfield parish hosted individuals participating in this year's Pilgrimage to End ICE detention run by SJRAISE partner Interfaith Movement for Human Integrity. Pilgrimage participants—including former detainees—traveled to detention centers throughout the state to protest the horrific conditions there. St. John's, Lodi member Charlene Martin was among the attendees, traveling with IM4HI to the Golden State Annex detention center in McFarland.

In addition to these efforts, SJRAISE was active in solidarity events and email campaigns for Stockton and Lodi residents who were in immediate danger of deportation. Those include Lodi resident Floricel Liborio, a single mother who received the wonderful news in August that she would not be deported to Mexico and separated from her children here in the United States. Members of St. John's, Stockton also gathered with members of the Latino Lutheran Mission in Stockton and Interfaith Movement for Human Integrity for a film and discussion about churches that have provided sanctuary for immigrants in detention.

Participants from the Central Deanery—including Church of the Saviour in Hanford—also supported Interfaith Movement for Human Integrity, providing masks at immigrant rights events in Fresno and Delano. SJRAISE kept active in the Central Deanery in other ways as well, providing financial support for an asylee family in Hanford and teaming up with the Mexican Consulate to dialogue about ways to offer supportive services to Mexican immigrants in the region.

Farmworkers were another major priority for SJRAISE this year, as we've learned that those who help harvest our food frequently struggle to eat themselves because of low wages and unfair labor practices. SJRAISE took an offering in June for the United Farmworkers Foundation, and congregations generously responded, raising more than \$1500. That same month, diocesan representatives participated in a rally in Bakersfield to protect farmworker union voting rights. SJRAISE and Latino Ministries also supported farmworkers by visiting them in the fields, and St. James Cathedral member

(and UFW Foundation employee) Linda Duran highlighted the needs of farmworkers in a video created by Padre Nelson.

In addition to the video on farmworkers, SJRAISE engaged in other educational efforts this past year. In June, the commission hosted an online panel on Queer Voices of Color in May in conjunction with the Anti-Racism Commission that included immigrant participants. Then, in September and October, SJRAISE teamed up with Latino Ministries for a book study on *Harvest of Empire*, which highlighted the history of Latinos in North America. The book study prompted wonderful discussions about how the Church should support the local Latinx community.

SJRAISE also supported immigrants through legislative advocacy. In April, a delegation from St. John's, Stockton traveled to Sacramento with students from San Joaquin Delta College to participate in the Day of Immigrant Action. It was inspiring to watch these junior college students—most of whom were undocumented "Dreamers"—meet with legislative aides and advocate for programs that support undocumented students on college campuses. Given that many immigrant policy matters are in the balance this election year, SJRAISE also engaged in advocacy by helping coordinate voter registration drives for U.S. citizens from immigrant backgrounds. These events not only helped encouraged historically marginalized community to vote, they helped us strengthen partnerships with wonderful organizations such as Mi Familia Vota and Poder Latinx.

Finally, it was wonderful to see the diocese continue the tradition of Las Posadas services in each of our deaneries. At St. James Cathedral, St. Paul's, Bakersfield and St. Francis, Turlock we commemorated the plight of the Holy Family as they searched for shelter, leading us to recall how immigrants today similarly need support as they search for a place they can call home. All three events were fun reminders of God's concern for the immigrant, as Jesus himself entered this world as a member of a refugee family.

As we look ahead to 2025, SJRAISE will continue to share Christ's love with immigrants in detention and farmworkers in addition to advocating on their behalf. This summer, we also plan to share information about the Episcopal Migration Ministries' Rainbow Initiative, which supports LGBTQ+ immigrants who are refugees or asylum-seekers. In addition, SJRAISE will team up with other commissions and diocesan representatives to highlight the connection between pesticides and Parkinson's disease, noting the direct impact on farmworkers. These efforts are being coordinated with UCLA and the Michael J. Fox Parkinson's Foundation.

Anti-Racism Commission

This year we had an ambitious agenda! Having just come off the passing of the resolution for EDSJ to Repudiate the Doctrine of Discovery, we created a "Toolkit" for congregations to use as a guide for engaging local indigenous communities, which included sample Land Acknowledgements, resources for local tribal councils, and a Eucharistic Liturgy for Indigenous Peoples Day (Oct 13). We also encouraged members of the commission and the diocese to attend the 3rd annual Orange Shirt Day Event in Sonora on Sept 30, and Canon Anna, along with members of St James Sonora were able to be present to enjoy drumming, dancing and keynote speakers on addressing the School to Prison pipeline for Indigenous children.

The Anti-Racism Commission continued the work of El Camino de la Pascua by returning to Allensworth State Park and inviting members of the diocese to join us for a tour and video presentation on this historic town in our midst. We also provided resources for congregations to celebrate Absalom Jones Feast Day, as well as Juneteenth.

In the early summer months of 2024, Bishop David charged us, along with the Creation Care Commission and SJRAISE, to have representatives from our commission join together with local community leaders to begin to address the use of pesticides and the prevalence of Parkinson's Disease in the Central Valley. This subcommittee known as "Pesticides & Parkinsons" has met several times and is partnering with UCLA medical, UC Davis medical, and the Michael J. Fox Foundation to get information out to farmworkers and farm owners about this concerning health hazard and the generational effects it has.

In the fall months of 2024, we also partnered with SJRAISE, the United Farm Workers Foundation, Clinica Sierra Vista, the Mexican Consulate's Office and Binational California to visit with farmworkers in the Central Valley and provide resources and snacks to those who provide food for the world. These visits are intended to build relationships with those who are often invisible in our communities.

To help all of us better understand the history of Hispanics and Latinos in our midst, we co-sponsored with SJRAISE this fall's book study on <u>Harvest of the Empire</u>. We are grateful to Padre Nelson Serrano and Padre Toni Alvarez for leading us in this study. We also give thanks to the two Padre's for their work on the Queer Immigrant Panel which they facilitated in June during Pride Month.

While we were ambitious in leading the diocese in addressing our racial biases and working to become Beloved Community, we acknowledge that we fell short in several areas, not limited to: not having programming for Women's History Month, not being able to secure a visit to Grinding Rock State Park, and not being able to achieve all the goals we set for ourselves at the Joint Commission Retreat in September 2023. Part of this was simply due to scheduling issues (General Convention year, Nuevo Amanecer year, co-chair sabbatical), and also the reality that it is time for us to extend invitations to members of congregations to help repopulate our commission.

We also want to express deep appreciation and gratitude for Ms. Constance Perry, a founding member of the Anti-Racism Commission and a member of the Racial Justice Commission in

the Diocese of Massachusetts. She assisted us with ZOOM book studies, establishing meeting norms, and modeled vulnerability for us in the early days of our work. She will be stepping down from the ARC in 2025 so that she can focus on reparations work in the Diocese of Massachusetts.

Creation Care Commission



Greetings to the Diocese of San Joaquin,

Here are reports from the diverse members of our Commission, reflecting on this past year of Commission work.

Barbara: I was encouraged preparing for Season of Creation. The music and liturgy, planned, celebrated this earthly kingdom. Other Sunday programs strengthen parish commitment to honor God's creation with sustainable practices. Amen!

Xan: I was encouraged to learn that rainwater harvesting is a lot more than putting a water collection tank on your rain spout; swales, berms, terraces, collection trenches and pools and keeping the earth covered, are also part of that, are very economical and help the rainwater in the water tanks go a lot further.

Reduce: When we reduce our intake of calories, we lose weight. When we reduce our consumption of resources and goods, we ease the burden on our planet and neighbors. While I support plant based plastics and silicon plastic alternatives, I'm not sending all the petroleum based plastics I already have to the landfill just yet. I toss a few in with the laundry and hang them on the clothesline and repeat until I can no longer reuse them. Similarly, I make washable "paper towels" from old shirts (some of which aren't cotton). When they finally wear out, the synthetic ones then go to the landfill and the cotton ones become mulch.

Rev. Bob: What was most important for me was, and remains, initiatives to plant more shade trees. More shade, especially in urban areas, reduces heat storage and local temperatures, thereby reducing energy costs for cooling as well. Especially needed in "concrete jungle" large cities.

Kim: A major contribution to our efforts to educate our parishes about care for creation was initiating Deacon Teri's and Bishop David's traveling workshops to share ideas, resources, and samples to support an ethic of "rethink, refuse, reduce, reuse, refurbish, repair, repurpose, and (as a last resort) recycle." I will continue to update our list of alternative sources, and continue to share positive news and caveats on the Fresno Interfaith Climate Alliance Facebook page.

Chuck: Transportation is the major user of fossil fuel. While we as a country have made progress in lowering our use of fossil fuel, we need to make bigger strides. Major reductions in fossil fuel are happening when we replace cars, trucks, buses with hybrid, plugin and electric vehicles.

The REDUCE campaign... aka the Creation Care Roadshow

We expressed to Bishop David a desire to connect directly with our churches this year so we could better serve anyone and everyone with useful information about Creation Care. Then we told him about our message for this year and he invited us to come with him on his visitations to deliver this message in person.

We all know the 3R meme for caring for the planet – Reduce, Reuse, Recycle. These three words refer to all the ways we can minimize the amount of materials we use, the amount of the Earth's resources we use, the energy we use, and the amount of waste we produce in our everyday life.

Our Commission members – Deacon Teri Van Huss, Chair, Kim Leslie, The Rev. Bob Woods, Chuck Shaeffer, Xan Adams, Barbara Krengle, and Canon Anna Carmichael - are all passionate and knowledgeable about the care of creation, and we decided as one mind, these three words are not equal in importance...and we prioritized them. Then we decided it's one word we want to convey as a message, and in capital letters.

It looks like this:

REDUCE...Reuse...Recycle

REDUCE...what we consume

REDUCE...what we throw away (...and who we throw away)

REDUCE...packaging (please use cardboard for garden/yard mulch)

REDUCE...food waste

REDUCE...our carbon footprint (carpooling, online meetings, etc.)

REDUCE...use of plastic bags and paper products (compostable ones, cloth napkins)

REDUCE...use of products made of synthetic chemicals, especially single-use plastic

REDUCE...the use of any product that harms the environment or ourselves (and this is really Gospel...)

What does REDUCE look like for you?

We ask you as church, we ask you as people of faith and lovers of Creation, to pass the word along. REDUCE...

If you haven't had a visit from the Creation Care Roadshow as yet, we will certainly see you in the coming months!

In a double-barreled approach, a second lawsuit was filed against ExxonMobil by a coalition of environmental groups, including the Sierra Club, Surfrider Foundation, Health of the Bay and

Baykeeper. Exxon is the largest producer of single-use plastics in the world, according to their lawsuit.

REPORT OF THE EDSJ DEPUTATION FOR THE 81st GENERAL CONVENTION for EDSJ 65th Annual Convention, November 9, 2024

The Diocese of San Joaquin sent eight deputies, two alternates and our bishop to the 81st General Convention of the Episcopal Church in Louisville, Kentucky on June 23 - 28, 2024.

The Diocese of San Joaquin was represented at the 81st General Convention by Bishop David Rice and our Deputation: Skylar Carlson, PhD (Lay 1), Jan Dunlap (Lay 2), Cindy Smith (Lay 3 & Chair), Nancy Fitzgerald (Lay 4), the Rev. Canon Anna Carmichael (Clergy 1), the Rev. Nelson Serrano Proveda (Clergy 2), the Rev. Dcn. Carolyn Woodall (Clergy 3) and the Rev. Suzy Ward (Clergy 4). Melissa Crider and The Rev. Toni Alvarez were also in Louisville as the 1st Alternates. Other Alternate deputies, not in-person at GC81, were the Rev. Dcn. Greg Masztal and Linda Masztal. Traditionally, every triennium the two Houses of General Convention – the House of Bishops and the House of Deputies - meet as the primary governing and legislative body of The Episcopal Church. The first General Convention was held in 1785 and, nearly 240 years later, the 81st General Convention of The Episcopal Church (GC81) once again gathered to do the work of the Church.

Our Bishop, eight deputies and two alternates attempted to "take the diocese with them" to Louisville, as each wrote one of the *Deputy Dispatch* daily essays of their experiences and reflections on the General Convention experience. The expanded GC81 *Deputy Dispatch* also contained a photo gallery, Canon Anna's Daily Quiz and links to live-streams, documents and news. Excerpts from each of the *Deputy Dispatches* are included in this Report to Diocesan Convention, so all our voices might be heard. A MODIFIED GC FORMAT BECOMES THE NORM

CENTERAL CONVENTION Z.

COUISVILLE

After the last, greatly abridged, 4-day 80th General Convention – with social distancing, no large group worship, daily COVID testing, and no exhibition hall, it was thrilling to have our triennial "great big Episcopal family reunion" that is General Convention back in full force. But, as sometimes happens in times of adversity, from the COVID impacted 80th GC came the realization that there are different, and arguably better, ways to structure our General Convention with thoughtful intention that allows wider participation and more voices heard, attention to care of creation, and reduced cost to dioceses, to name but a few considerations. Most of the Legislative Committee (LC) work was completed prior to the arrival of approximately 800 Deputies and 200 Bishops in Louisville, Kentucky. Four months of virtual LC meetings allowed for testimonies on proposed resolutions by many from throughout the wider church, not just those gathered at GC81. The six legislative days that began June 23 with three days of events before, was shorter than most past conventions, where legislative sessions typically spanned eight days or longer. [portions by ENS] Second-time Deputy Nancy Fitzgerald summed up her thoughts on the virtual preparation for General Convention, "Zoom meetings and other types of live virtual interactions save time, cost, and resources of the planet, and allow those very far away to be on the same committees, to watch committees work, and all be at the table."

OUR DEPUTATION'S WORK CONTINUES IN LOUISVILLE

First-time Deputy Toni Alvarez marveled at events even before the opening gavel of the first business session, "There are so many facets to this large gathering from across this Episcopal Church of ours. Obviously, its purpose as a legislative and governing body looms large in minds of the deputies gathered, but worship was the first order of business. The revival was held last night where the Presiding Bishop gave a rousing sermon on love, and a multicultural band sang bilingual songs as Episcopalians sang, danced, and clapped along. That was followed by our first convention Eucharist

this morning where the bilingual music rang out again, and we heard a sermon full of hope and optimism about the future of our church from President of the House of Deputies Julia Ayala Harris."

Six-time Deputy Jan Dunlap described the opening business session of GC81 later that day where House leaders gave their opening messages, "President Ayala Harris delivered a message of affirmation for challenges faced, and hope and encouragement for our work ahead. Presiding Bishop Michael Curry bid us farewell in his message as his term ends in November when the newly elected PB from this Convention will replace him. While listening to his message, I was reminded what a gift Bishop Curry is to our church. In his unique delivery style, he reminded us once again that God is love and we are created to be an expression of God's love. He admonished us not to worry about the Episcopal Church, not to weep, but to roll up our sleeves and get to the work."

Our GC81 Deputation is rather unique, as observed by Deputation Chair and six-time Deputy Cindy Smith, "The Deputation to GC81 is transformative. Of our 10 Deputies and first alternates, we have five who have served at one to five previous GCs and five who are first time deputies. In my opinion, this is how it works. The seating of the eight deputies on the floor of the House is a wonderful mix of fresh enthusiasm and experienced wisdom. We sit together with the veterans helping the first-time deputies maneuver the vBinder.net information portal, parliamentary procedure and, perhaps most importantly, the strategies to make good works come to fruition. It is a blessing to transfer the institutional knowledge to the next cohort of Deputies for the benefit of San Joaquin!" First-time Deputy Nelson Serrano Proveda felt it went beyond just previous experience, "Friends of EDSJ, I'm so excited watching our deputation. We have a very diverse group of people who indeed represent who we are: white people and people of color, LGBTQ+ people, immigrants, farm workers, English and Spanish Speakers. EDSJ, we are a diverse Diocese, as diverse as our deputation. Let's be proud of who we are, and please pray for us."

Many from San Joaquin were appointed to Legislative Committees at GC81: *Environmental Stewardship & Care of Creation* - Bishop David Rice, *Title III - Ministry* - Deputy Jan Dunlap; *Governance & Structure* - Deputy Cindy Smith; *Safety, Wellness & Mental Health* - Deputy Anna Carmichael; *Evangelism & Future Church* - Deputy Nelson Serrano Proveda; and our own Chancellor Mike Glass also serves as the Chancellor to President of the House of Deputies.

THE LEGISLATIVE SESSIONS BEGIN

While in Louisville, 390 Resolutions moved through the 2 Houses; the Deputies re-elected Julia Ayala Harris as House of Deputies President and elected the Rev. Steve Pankey as Vice President; both Houses passed a \$143 million budget for the next triennium; and approved a constitutional change to clearly define the breadth of the Book of Common Prayer..."Those liturgical forms and other texts authorized by the General Convention per this article and the Canons of this Church."

First-time Deputy Carolyn Woodall recounted Deputy Anna's addressing of the house during the joint session of both Houses for the discussion and debate of the \$143 million budget, "During the debate period, our own Canon Anna Carmichael made a statement. She encouraged that we not look at the budget as one of allocating scarce resources, but rather as aspirational to ensure we exercise proper and effective stewardship." First-time Deputy Melissa Crider had this reflection after the budget discussion, "I was especially moved by discussions of and questions regarding Creation Care and Youth Ministry. We were reminded that budgets tell stories, and I was struck by the stories that members of our Church wish to tell; stories of a brighter, more just, and more secure future that awaits manifestation."

A NEW PRESIDING BISHOP IS ELECTED

The convention elected the Rt. Rev. Sean Rowe, bishop diocesan of Northwest Pennsylvania and bishop provisional of Western New York, to be its the 28th presiding bishop, and the deputies confirmed that act with a nearly unanimous majority, 95% in favor [ENS]. Bishop David Rice spoke of the selection of our next Presiding Bishop for a nine-year term by his House of Bishops, "... bishops exited the worship space and assembled to join in a two block *camino* from the Convention Center, the venue for GC81, to Christ Church Cathedral, where today's Presiding Bishop Election took place...The *camino* was slow and deliberate and in an Anglican manner, orderly. Under, overcast skies, we encountered many people along the way, taking photographs, offering prayers and wishing us well in the election before us...there was a strong sense of being held in the hands of God and God's Church, with a decision set before us... During the course of the next hours, we sang hymns, we prayed, we embraced the silence of the space and then, we elected one of our own... Following the announcement from a delegation from the House of Deputies, communicating consent regarding the Presiding Bishop-Elect, we departed Christ Church Cathedral, under clear skies. And I can say, with absolute certainty, celebrating continued hope for The Episcopal Church."

Presiding Bishop-Elect Sean Rowe, at 49 years-of-age, is the youngest bishop ever elected as PB. He has made recent remarks indicating that the long sought-after "strategic adaptive realignment of our institutional structures" in The Episcopal Church will begin shortly to save upwards of \$3.5 million in this triennium's budget. An initial example of these intentional changes was given by his announcement that the traditional elaborate installation service at Washington National Cathedral will not occur as originally announced. Instead, a simpler rite will take place Nov. 2 in the small chapel at the Church Center in New York. Rowe said he has "decided to begin this ministry in a new way." The service will be live-streamed, and simultaneous interpretation will be available in multiple languages to ensure church-wide access. He has also emphasized to the Joint Budget Committee that more of the church's focus and resources should be shifted to the diocesan and congregational level. "As a church, I think we understand that ministry happens on the ground," he said. [portions attributed to ENS]

A TIME FOR SOCIAL JUSTICE & ALWAYS FOR PRAYER

Outside the legislative chambers, several events brought together bishops, deputies and visitors to mingle, socialize, pray, worship and advocate. Convention continued the church's public witness against gun violence in a march through downtown Louisville, where bishops wore orange stoles, and members of Youth Working to End Gun Violence stood at the front of the procession with the bishops and carried the banner. The march began at the Convention Center and ended at Jefferson Square Park. Those gathered listened to youth speak about the impact of gun violence on their lives and their call to end gun violence. Several bishops spoke as well, and the gathered crowd prayed and sang as they bore public witness. [ENS] Later during the afternoon legislative session, the Diocese of Kentucky handed out placards to every diocese noting the city within their home dioceses where a mass shooting occurred in 2023. The House of Deputies actions were described by Deputy Carolyn, "We passed a resolution encouraging the United States to prohibit assault weapons, including the use of bump stocks, which have become the weapon of choice for the all too frequent and tragic mass shootings. We also passed a resolution condemning the growing practice of book banning."

A panel discussion on the church's role in Indigenous boarding schools built on the awareness fostered and testimonies heard at the previous General Convention. First-time Deputy Skylar Carlson explained the legislation that followed the panel discussion session, "We approved a prayer for the remorse of the Church's role in the establishment of those schools and the propagation of the crimes against those children. The prayer also begs the memorialization of the souls of indigenous children in liturgies throughout The Episcopal Church."

Five-time Deputy Suzy Ward emphasized the importance of prayer in the work being done at GC81, "This year, as the House considered resolutions about the climate crisis, the on-going war in Gaza, or the role of the Episcopal Church in the deaths of innocent children at Indigenous Boarding Schools, the President of the House would call on Lester [The Rev. Lester Mackenzie, Chaplain of the House of Deputies] to pray, before or after a vote...For Lester, this job as chaplain, is about helping us to breathe the Spirit into our governance. In the context of South African theology, to be seen comes as we see each other. For me to be seen, requires me to see you. 'I am, because you are...What do we risk when we experience joy with our neighbor? What do we risk when pray over each other?' "

Deputy Melissa attended an optional evening service offered by a neighborhood Episcopal church in Louisville, "I attended Compline at the beautiful church of St. Francis in the Fields. The congregation of St. Francis welcomed their visitors with warmth and love. I sat in a pew, listening to St. Francis' choir, watching the flames of the candles that were set up throughout the sanctuary flicker and dance. We spoke the words of our prayers together, sang together, and listened together. And sitting there, amongst those strangers who are not really strangers but truly my Siblings in Christ, we lived out the theme of the 81st General Convention: we were Together in Love."

TITLE IV DISCIPLINARY REFORMS

One of the top issues heading into Louisville was how the church might reform its Title IV Canon referring to clergy discipline. General Convention routinely reviews and updates Title IV, though this year a series of proposals were submitted specifically in response to concerns across the church that the current disciplinary process sometimes causes secondary harm to complainants and that bishops are not always held to the same disciplinary standards as other clergy. The bishops' and deputies' Title IV committees were assigned 28 resolutions, and nearly all either were passed by both houses, with or without amendment, or were referred to an interim body for more study over the next three years. [ENS]

CHANGES FOR SEVERAL DIOCESES

Deputy Cindy recounted "At GC81, we have also addressed legislation for the merging of dioceses; the reduction of assessments to dioceses by The Episcopal Church (TEC); and increased funding of provinces by TEC. A unique resolution in this GC focused on how to best provide help the Diocese of Haiti (the largest diocese in TEC by population) as it struggles through a crisis created by the political instability that currently exists in their country. The Church strives to assist in the resolution of this situation, all while adhering to Haiti's Canons and respecting the autonomy and desires of the Haitian people."

She continued, "On Tuesday, after decades of effort the Area Mission of Navajoland's petition to become a Missionary Diocese was passed by an overwhelming acclimation of Convention. Priests, laity and elders from Navajoland spoke eloquently about the similarities of the Dine culture and the Episcopal Church, as with both "I will walk in beauty". The elder thanked the Convention, telling us "Peace has Returned". The Diocese of Alaska feels great kinship with Navajoland's path and presented a beautiful gift "from my heart to yours". As a Missionary Diocese, Navajoland now has greater autonomy and self-governance."

Deputy Carolyn added, "The Episcopal Church in Navajoland status as a Missionary Diocese grants them independent governance in matters such as election of their own bishop and raising up indigenous clergy. The deputation from Navajoland was invited to the platform to speak to us. They were presented with a gift from the Diocese of Alaska – a beautifully crafted framed cross. This was easily the most moving part of the day - well, actually, the entire convention to this point." The 81st convention approved an unprecedented four changes to dioceses in a move that could presage greater consolidation and diocesan cooperation for mission and ministry. Bishops and deputies agreed to allow the dioceses of Eastern Michigan and Western Michigan to form the new Diocese of

the Great Lakes, while Eau Claire, Fond du Lac and Milwaukee got the go-ahead to reunite as the Diocese of Wisconsin. Convention approved to merge Micronesia, an area mission, with the Diocese of Hawai'i. [ENS]

HAVING FUN WITH LOUISVILLE'S DISCO LEGACY

Deputies took full advantage of the fact that Louisville has produced 90% of the world's disco balls, and the city remains the only city in the U.S. still making them. The house's June 26 evening session was dubbed the "House of Deputies After Dark" with glow sticks, colored lights and disco music. [ENS] Deputy Skylar described it to the folks back home, "Tonight, after a quick dinner break, the house will meet again for what the Madam President Julia Ayala Harris calls the Episco-Disco After Dark or the House (of Deputies) Glow Party. When this happened last night, the President's office distributed various glow themed party items – light up glasses, fun cat ears, and glow sticks. Don't worry, lots of business got done despite the fun." And, as convention closed its Virtual Binders for good on June 28, HoD President Ayala Harris awarded the disco ball trophy to the three dioceses that are newly reuniting as the Diocese of Wisconsin for having the best-decorated stanchions marking their deputations' places on the House of Deputies floor. The stanchions for Eau Claire, Fond du Lac and Milwaukee featured puzzle pieces that fit together as their new Diocese of Wisconsin.

WHY YOUR DEPUTIES LOVE REPRESENTING EDSJ AT GENERAL CONVENTION

The Deputy experience allowed for time to meet new friends, catch-up with long-time far-flung friends, do some work we are called to do, and hear amazing stories of witness and service. Four-time Deputy Anna Carmichael celebrated the opportunity for "supporting and mentoring rising leaders in our midst. ...it has been my joy to 'tap out' and give my seat to [Alternate Deputy] Padre Toni. He's done a fabulous job encouraging our deputation to stay in good spirits and work through an exhaustive legislative calendar, and I am grateful for his leadership." She also explained that time off the floor allows her "to reconnect with clergy from across the church and to connect with prospective clergy, in order to share the good news of San Joaquin. I was able to connect with those who are working to address clergy and lay burnout, those who are working to create new diaconate training programs, those who are creating resource hubs for anti-racism training materials, and those who are finding creative ways to make the church more welcoming and inclusive for our youngest members. "

Deputy Melissa: "When I voted, I saw, so clearly, what an incredible privilege it is to participate in this process alongside Episcopalians from all over our worldwide Church. It has been truly moving."

Deputy Suzy: "At General Convention, we do worship with close to 1,000 people every day!"

Deputy Nancy: "There is a lot of work being done and more to do in the next few days... I am so grateful to be able to do this work, to learn so many new things, to meet such wonderful people, and I thank my family and the Diocese of San Joaquin for this opportunity."

Deputy Jan: "For me, a priceless outcome of convention are the relationships formed and the learning gained through the very talented and diverse members of our church...I am looking forward to discovering what the Holy Spirit will enable through us in this Convention's time together."

Deputy Toni: "We deepened our relationship with one another as we learned more about this delightfully peculiar church of ours... I see the prayerful earnestness and diligence shown by this assembly I am moved to gratitude that I am here."

And, as is tradition, saving the last word for our Bishop David: "We have much to do to ensure that the Jesus Movement in The Episcopal Church continues to grow. And, I have every confidence that under the leadership of Bishop Sean Rowe, the loving, liberating and life-giving way of Jesus will do that very thing, grow, it will."

1. THE CHAIR CALLS THE MEETING TO ORDER

a. The Rt. Rev. David Rice, Bishop, called the annual meeting to order at 10:50 a.m. and gave a Land Acknowledgment: "We acknowledge that this Virtual Meeting is taking place throughout the unceded territory of California home to nearly 200 tribal nations. As we begin this event, we acknowledge and honor the original inhabitants of our various regions. A land acknowledgement is a critical step towards working with native communities to secure meaningful partnership and inclusion in the stewardship and protection of their cultural resources and homelands. Let's take a moment to honor these ancestral grounds that we are collectively gathered upon and support the resilience and strength that all Indigenous people have shown worldwide."

2. EXPLANATION OF NEW PROCEDURES ON VIRTUAL PLATFORM

- a. Bishop David called upon Cindy Smith, the Secretary of Convention, to provide procedural information for today's meeting. The Secretary announced that today's convention would be recorded. She brought attention to the use of the Electronic Convention Booklet (ECB) throughout the meeting.
- b. The Secretary explained that if you wish to address Convention, raise your hand. Once you are recognized by the Bishop, please stand in place, if able, and identify yourself with your name and parish before making a motion or second, even if the Bishop has used your name which is vital for the official audio recording of the meeting. To speak to an issue, bring forward a new motion or have a question, step to the microphone and wait to be recognized by the Bishop. Once recognized, always identify yourself with your name and parish before proceeding.
- c. The Secretary instructed attendees wishing to submit late resolutions and/or budget amendments from the floor to submit them in written form at the dais and also via email to the Secretary of Convention by 11:15 a.m., and reminded convention that a Late Resolution must receive a 2/3rds majority vote in order to be considered, or 3/4ths majority if it seeks to amend the Diocesan Canons and/or Constitution. If the Motion to Consider passes, discussion and a vote to adopt may take place.
- d. Voting procedures would be reviewed prior to the first vote.
- e. The Bishop reminded those present that this business session was a form of worship in the life of the church and the manner in which those present conducted themselves during the meeting was important. The Bishop shared that Chancellor and Parliamentarian Michael O. Glass was only present via Zoom as he was still recovering from Covid, and that some items typically presented by the Chancellor would be presented by the Secretary or others.
- f. The Bishop called upon the Secretary of Convention to step the delegates through a review of Convention Delegate protocols and best practices for members of Convention.
 - 1. Once you are recognized by the Bishop, even if he uses your name, state your name &

church, so it may be correctly recorded in the minutes.

- 2. State why you are speaking To make a motion; To second a motion on the floor; To enter the discussion or debate, while also indicating whether you wish to speak for or against the issue; or To ask a question.
- 3. Who may vote. If you are an elected delegate or canonically-resident clergy, you have Seat, Voice & Vote. If you are an observer, you typically do not have Seat, Voice or Vote. Some groups are granted Seat & Voice as a courtesy Dio Council, Standing Committee, Deputies, etc., so they might participate in debates and discussions. If you do not have "Vote" you may not vote, or make a motion, or second a motion.
- 4. Delegates can offer an *amendment* a proposed resolution or another person's motion rather than just voting "No". If a majority agrees to the amendment, it will modify the original resolution or motion. Convention will then vote again on the amended resolution or amended motion as a final action. When you propose an amendment, you must submit precise language of the proposed change, typically in writing.

3. INTRODUCTION OF NEW CLERGY

- a. Bishop David introduced and welcomed our new clergy.
 - Rev. Betsy McElroy, St John's, Lodi

4. TAKING OF THE ROLE AND REPORT OF QUORUM

- a. Bishop David called upon the Secretary of Convention for a report of the Registration of Clergy and Lay Delegates and the report of the Credentials Committee as to the presence of a Quorum.
- b. Ms. Cindy Smith reported that the Credentials Committee Chancellor Michael Glass, Registrar The Rev. Canon Anna, and Secretary of Convention Ms. Cindy Smith - certifies that at least one-third of all clergy entitled to seat and vote are present and at least one-third of all congregations are represented by at least one lay delegate which constitutes a quorum per Canon 3, Sec. 1 of the Diocesan Canons.
- c. Bishop David thanked the Secretary, and declared a Quorum is present and the Convention is organized for business.

5. CONVENTION APPOINTMENTS

- a. Bishop David made the following appointments for the 64th Annual Convention of this diocese:
 - Secretary of Convention: Ms. Cindy J. Smith
 - Chancellor and Parliamentarian: Mr. Michael Glass
 - Dispatch of Business: The Rev. Gail Bernthal

6. MOTION TO ADOPT THE AGENDA AND CONSENT AGENDA

a. Bishop David called upon The Rev. Gail Bernthal, Dispatch of Business. The Rev. Gail Bernthal moved to adopt the proposed agenda as printed beginning on page 4 of the Electronic Convention Booklet (ECB) distributed to the delegates, and be entered into the record. Bishop David reminded convention, when making and seconding motions, please use the "raise hand" feature on the virtual platform and, once recognized, to state your name and parish for the record.

- b. Bishop David called for and received a second from Dcn. Terry March, St. Paul's, Visalia. Bishop David called for discussion; hearing none, Bishop David called upon Cindy Smith, the Secretary of Convention, to review all voting procedures.
- c. The Secretary reviewed voice vote or raised hand vote for most Y/N votes, and the new vPoll web-based platform that we will use for the Election Ballots and voting to accept the budget and adopt resolutions. Convention was reminded that only elected delegates and canonically resident clergy should vote, alternates should not vote unless they have been seated as replacing the original delegate.
- d. The Bishop asked convention if a practice vote on the vPoll platform was needed as a tutorial and practice had already taken place earlier in the day. Convention was comfortable to proceed without additional practice. The Bishop recognized Ms. Jan Dunlap, St. Paul's, Bakersfield who cautioned convention to check that there vPoll login was now connected to the business meeting session rather than the practice session from earlier in the day.

Bishop David called for a Yes/No voice vote to adopt the agenda. Motion carried.

- e. Bishop David called upon Dispatch of Business to introduce the Consent Agenda and explain the adoption process. The Rev. Gail Bernthal explained: The Consent Agenda, as printed on page 6 of the convention booklet, distributed to delegates, will be enacted as a whole by one motion and one vote. If discussion is desired by the Convention on any Consent Agenda item, any delegate may request to remove that item by raising your hand to be recognized. The Chair of Convention will remove that item from this agenda to be considered in the regular order of business.
- f. The Rev. Gail Bernthal moved to adopt the Consent Agenda, as printed and distributed to the delegates. Bishop David called for and received a second from Ms. Lori Toia, St. Paul's, Bakersfield. Bishop David called for discussion; hearing none, called for a Yes/No voice vote to adopt the Consent Calendar. Motion carried. (see Exhibit section for Consent Calendar text)

8. REPORT OF CONGREGATIONS IN ARREARS IN ASSESSMENTS

a. In the absence of the Diocesan Treasurer, Bishop David called on the Assistant Diocesan Treasurer, Ms. Nichole Pardo, to report those congregations who are in arrears in assessments. The Diocesan Treasurer reported, "Bishop David, the Treasurer certified that the following congregation is delinquent in their assessment payments: St James Cathedral, Fresno. According to Canon 2 Section 5, they are removed from the roll and ineligible for seat, voice, and vote without action by this convention. However, based upon the Consent Agenda just passed by this Convention, that congregation is granted seat and voice." The Bishop thanked and excused the Assistant Treasurer, and gave further explanation of the Cathedral's financial situation and thanked those representatives of the Cathedral attending as visitors.

- a. Bishop David asked the Chair of Nominations, Ms. Jan Dunlap, if any nominations have been received electronically during the meeting. The Nominations Chair reported no nominations have yet been received.
- b. Bishop David called for all nominations from the floor for Standing Committee, Lay position; there were none; called for a motion to close nominations for this position. Deacon Nancy Key, St. James' Cathedral moved that nominations be closed for Standing Committee Clergy; second by Mr. Lejf Knutson, Episcopal Church of the Saviour, Hanford. Bishop David called for discussion; hearing none, called for a voice vote to close nominations. Motion carried.
- c. Bishop David called for nominations from the floor for Standing Committee, Clergy position; Deacon Teri Van Huss nominated Rev. Luke Martinez, Episcopal Church of the Saviour, Hanford; second by Ms. Tamzin Wheatley, Episcopal Church of the Saviour, Hanford; Deacon Nancy Key, St. James' Cathedral nominated Rev. Jessica Harmon, St. James' Cathedral; second by Deacon Tom Hampson, St John's, Lodi; Deacon Tom Hampson, St John's, Lodi nominated Rev. Rebecca Blair, St Anne's, Stockton; second by Deacon Carolyn Woodall, St Anne's, Stockton. Each nominee accepted their nomination. Mr. Lejf Knutson, Episcopal Church of the Saviour, moved that nominations be closed for Standing Committee Clergy; second by Deacon Carolyn Woodall, St Anne's, Stockton. Bishop David called for discussion; hearing none, called for a voice vote to close nominations. Motion carried.
- d. Bishop David called for nominations from the floor for Diocesan Council, At Large, Lay position. Ms. Amber Darby, St John's, Stockton, nominated Dr. Skylar Carlson, St John's, Stockton; second by Ms. Grace Dah, St John's, Stockton; the nomination was accepted. 13. VIDEO – THE TUTU DISK CAMPAIGN

a. Bishop David introduced the video. Following the video Canon Anna Carmichael announced a desk campaign to be held within EDSJ over the next year, asking each congregation to raise \$100 which would fund 5 Tutu Desks in South Africa to make a difference in the lives of children.

14. FIRST BALLOT

- a. Bishop David called upon The Secretary to explain the ballot voting method with the vPoll platform. It was explained as follows: "All certified delegates and eligible clergy shall vote one selection each for the Standing Committee and Diocesan Council offices. For an Election ballot, you will go to the voting portal, select the Business Meeting, and login with the unique credentials that were sent to you. Do not share your credentials if you do not have your credentials, raise your hand for assistance. You will be presented with a ballot, which will include instructions on how many candidates to vote for. The ballot will appear on your screen and you have two minutes to submit your ballot, a timer appears at the top. As we approach the two minute mark, the Bishop will say "the vote is closing," then "the vote is closed." The Bishop will then proceed to the next office election, and the third office election. The certified results of the first balloting will be reported later in the meeting."
- b. Bishop David verified with the Secretary and the Technical Production team that the voting platform was ready. The Bishop announced the vote open, asking for selections to be made. After sufficient time, he announced the vote closed. He repeated the process for each office.
- b. The Bishop announced that first balloting is now closed and results would be reported later.

15. VIDEO – Episcopal Youth Event (EYE)

a. Bishop David introduced the video, and expressed EDSJ's continued intention to participate in EYE.

16. CHANCELLOR'S REPORT - Mr. Michael Glass, Chancellor

a. Bishop David acknowledged the long and faithful service by The Chancellor. As the Chancellor was unable to attend in-person due to Covid to present his verbal report, we were directed to the written report that was submitted.

17. VIDEO - DIOCESAN SOLAR DEPLOYMENT PROJECT STATUS REPORT - Mr. Cal Harling

- a. Mr. Cal Harling, Solar Project Consultant for the Diocese, delivered his pre-recorded video report.
- b. Mr. Harling's video covered Phase I and Phase II of the development, common questions, and a discussion of the Episcopal Renewable Energy Non-Profit (EREN). Highlights of his report included:

PHASE I STATUS:

All systems are constructed and interconnected.

PHASE II STATUS:

All systems interconnected except ECOS, Hanford and St. Paul's, Visalia awaiting sign-off to be interconnected

QUESTIONS RECEIVED:

Should dirty panels be cleaned? No, we are not the owners of the system and our agreement with the PPA states we will not touch the panels. The interconnection back to the maintenance monitoring company gives an alert when the panels are low producing and in need of cleaning.

Why did we have to pay at true-up? Commercial systems cannot zero out your utility bill. There are some non-bypass charges and fees that you must pay. Also, sometimes systems are not sized to 100% of usage or the system may be under-producing. Thirdly, your utilization may have gone up.

STATUS OF EPISCOPAL RENEWABLE ENERGY NON-PROFIT (EREN) - CREATED IN APRIL 2022:

- Diocese of Missouri In process of signing engagement
- Presbytery of San Francisco Awaiting final approval of engagement by their Building Committee
- Cal will work with EDSJ Treasurer to break-out into detail the single line item in EDSJ financial report
- c. Mr. Harling invited additional question to be sent via email. The Bishop thanked Mr. Harling for his presentation, and encouraged those attending to read the recent Episcopal News Service article on EREN and Cal Harling's work.
- d. The Bishop called Convention in recess for 45 minutes for lunch at 12:05 p.m.
 - e. The Convention resumed after the luncheon recess.

18. FINANCIAL REPORTS AND MOTION TO APPROVE BUDGET

- a. Bishop David explained to Convention that the 2024 Proposed Budget was presented in detail to all delegates and others attending the September Deanery Day, and they have had some time to examine it in detail. He asked Convention to limit discussion to additional questions not already addressed at the previous budget presentation.
- b. In the absence of the Diocesan Treasurer, Bishop David called upon Ms. Nichole Pardo, Assistant Diocesan Treasurer, to present the 2024 Proposed Budget. The Treasurer's Report, the 2023 Financial Reports, and the Proposed 2024 Budget can be found on pages 10 through 25 of the Electronic Convention Booklet/ECB.
- c. Ms. Pardo presented the following statement by the Diocesan Treasurer, "The 2023 financial report is presented through the end of September. Even with the market drop in quarter 3, we are still tracking at budget on September 30th. After much work done by the Finance Committee, especially the work of Nichole Pardo and Deacon Teri Van Huss, we were pleased to present the 2024 Proposed Budget to Diocesan Council and then, on Deanery Day in September, to the delegates and clergy. Bishop, I present the 2024 Proposed Budget to Convention."
- d. The Bishop thanked the Assistant Diocesan Treasurer, and called upon the chair of the Finance Committee, Dcn. Teri Van Huss, to request a motion to approve the budget as proposed by our Diocesan Treasurer.
- f. Dcn. Teri moved, "That the 2024 budget as presented by the Assistant Diocesan Treasurer, be approved by this Convention and entered into the record." Bishop David called for and received a second from Mr. Xan Adams, St. Matthew's, San Andreas. Bishop David called for discussion; hearing none, called for a Yes/No electronic vote to confirm. Motion carried. (42/0) Bishop David expressed thanks for all those who toiled to create and present the budget.

19. RESULTS OF FIRST BALLOT

a. The Secretary requested and was granted recognition from The Chair to announce election results for the First Ballot. The Secretary declared that the results were final for the offices where elections have been made for the open positions within the office, and announced the results:

The Secretary announced the election results for Standing Committee – Lay:

Ms. Cindy Smith, St Paul's, Bakersfield was elected with 32 votes

Mr. William Patterson, St James Cathedral, Fresno received 13 votes

The Secretary announced the election results for Standing Committee – Clergy:

The Rev. Rebecca Blair, St Anne's, Stockton was elected with 21 votes

The Rev. Luke Martinez, Episcopal Church of the Saviour, Hanford received 15 votes

The Rev. Jessica Harmon, St James Cathedral, Fresno received 10 votes

The Secretary announced the 2nd ballot election results for Diocesan Council – At-Large Member Lay:

Dr. Skylar Carlson, St John's, Stockton was elected unopposed with 46 votes

- b. Deacon Greg Masztal, St Paul's, Modesto was recognized for a point of order, and stated that the results as "elected" of the Standing Committee Clergy Ballot were misreported, as the 21 votes were not a majority of the 46 votes cast, and a majority is required on the first ballot.
- c. The Bishop and Secretary confirmed this point of order and a second ballot was called for the Standing Committee Clergy election. The Bishop proceeded to item 20, to allow time for the creation of the second ballot.

20. VIDEO - SJRAISE

a. Bishop David introduced the video, and pointed out that SJRAISE was "our longest standing diocesan commission and continues to do stunning work".

21. SECOND BALLOT

- a. Bishop David called upon the Secretary of Convention to explain the Second Ballot for the office of Standing Committee-Clergy. She explained that pursuant to Canon 7.06 "On a second or subsequent ballot anyone receiving a plurality of votes...shall be declared elected." The winner is determined by the most votes on a second ballot, a majority is not required.
- b. The Bishop announced the vote open, asking for selections to be made. After sufficient time, he announced the vote closed.
- c. The Bishop announced that second balloting is now closed and requested results be immediately broadcast and announced.
- d. The Secretary declared that the results were final for the offices where elections have been made for the open positions within the office, and announced the results for Standing Committee Clergy:

- f. Bishop David called for any discussion; he recognized The Rev. Suzy Ward, St. Paul's, Visalia, who observed that a report from the Visalia Homeless Center was submitted but was not included. The Bishop stated that that report would be included.
- g. Bishop David called for any further discussion, hearing none, he called for a Yes/No voice vote. Motion carried.

a. Bishop David introduced the video, and drew parallels between multiple issues within the work on anti-racism.

Yes/No voice vote to accept the Resolutions of Courtesy. Motion carried.

28. VIDEO - CREATION CARE COMMISSION

a. Bishop David introduced the video, and noted that EDSJ is known throughout The Episcopal Church as a "Creation Care Diocese", yet there is still a lot of work to do as Mother Earth still groans.

29. APPROVAL OF MINUTES OF THE 63rd ANNUAL DIOCESAN CONVENTION OF 2022

- a. Bishop David asked the delegates to refer to the Minutes of the 63rd Annual Diocesan Convention of 2022 in their ECB/Electronic Convention Booklet on pages 57 through 76, and asked for a motion to approve the Minutes of the Annual Convention of the Diocese of San Joaquin, held on November 5, 2022 as printed.
- b. Ms. Tamzin Wheatley, Episcopal Church of the Saviour, Hanford moved to approve the minutes as printed; seconded by Ms. Nancy Fitzgerald, St Raphael's, Oakhurst.
- c. Bishop David called for discussion or corrections; hearing none, called for a Yes/No voice vote. Motion carried.

30. REPORT FROM THE CHAIR OF THE COMMITTEE ON RESOLUTIONS

- a. Recognizing the absence of the Mr. Michael Glass, Chair of the Committee on Resolutions, Bishop David presented a review of the report of the Resolutions Committee.
- b. The Bishop announced that Resolution 2023-R001, Repudiation of the Doctrine of Discovery; 2023-R002 Celebration of the 50th Anniversary of the Ordination of the Philadelphia 11; and 2023-R003 Diocesan-wide Recognition and Support of the work of Episcopal Relief and Development, are available for reference in the convention booklet, pages 26 through 34

RESOLUTION 2023-R001 (see Exhibit section for resolution text)

- c. The Bishop addressed 2023-R001 and confirmed that the resolution was reviewed by the committee, was timely submitted, and did not report to change the Canons or the Constitution. It was in order. The required vote is a simple majority.
- d. The Bishop invited Rev. Toni Alvarez, resolution sponsor, to speak to Resolution 2023-R001. He related that this resolution focused on the repudiation of the Doctrine of Discovery within our diocese. Some of these instances were focused on during the recent Camino including a massacre of indigenous people and an "Indian Boarding School" in Northfork. He clarified aspects of the resolution that have been of concern to some, involving the language of native Mexicans and indigenous peoples in EDSJ.
- e. The Bishop announced that this resolution requires a simple majority to pass and called for a motion to accept the resolution. Rev. Toni Alvarez, St Francis, Turlock moved for the acceptance of the resolution.
- f. Bishop David called for a second. Ms. Beryl Simkins, St Francis, Turlock seconded.
- g. Bishop David called for discussion; and recognized Mr. Xan Adams, St Matthew's, San Andreas who spoke in favor of the resolution after the clarification of language.
- h. Bishop David called for any additional discussion, hearing none, called for a Yes/No voice vote. Resolution adopted.

- b. The Secretary reported, "I certify that the proceedings of this convention have been adequately recorded to produce a reliable and accurate record of the business meeting of this 64nd Annual Convention of the Diocese of San Joaquin, November 11, 2023."

33. ANNOUNCEMENT OF ORGANIZATIONAL MEETINGS

a. Bishop David announced organizational meetings for ALL members (including both incoming and outgoing) of Diocesan Council and Standing Committee immediately after the Noonday Prayer that follows the Convention business meeting.

34. MOTION TO SET DATE AND LOCATION OF THE 65th ANNUAL CONVENTION

- a. Bishop David explained to the assembly: "Per Diocese of San Joaquin Constitution Article 5. Section 2, Annual Convention shall commence at a place and on a date set by resolution of the previous Annual Convention between October 1st and November 15th. I propose the date of the 65th Annual Convention be November 8th 9th, 2024 at ECCO." Mr. Lejf Knutson, Episcopal Church of the Saviour, Hanford made the motion.
- b. Bishop David called for a second. Ms. Jan Dunlap, St. Paul's, Bakersfield seconded.
- c. Bishop David called for discussion, hearing none, called for a Yes/No voice vote. Motion carried.

33. ADJOURNMENT AND BLESSING, NOONDAY PRAYER

- a. Bishop David offered thanks to the Convention and asked for a motion to adjourn the 64th Annual Convention of the Episcopal Diocese of San Joaquin, Ms. Amber Darby, St. John's, Stockton moved to adjourn, seconded by Deacon Tom Hampson, St. John's, Lodi. Bishop David called for a Yes/No voice vote to adjorn. Motion carried.
- b. Bishop David thanked Convention and acknowledged that the work can be difficult at times, but it is holy work and was well done. Bishop David invited those gathered to stand, if able, for a closing blessing.
- c. Meeting was adjourned at 1:49 p.m.

Convention Delegates may give of their time to another, but no single individual may exceed five minutes on any one motion. As a matter of courtesy, motions to "Call the question" or "Call the previous question" is out of order as long as one or more delegates have been acknowledged by the moderator are in the queue awaiting a turn to speak, unless there have been already five persons

speaking for and/or against the issue.

Required Vote: Simple Majority

RESOLVED, that the 64th Convention of the Episcopal Diocese of San Joaquin repudiates the Doctrine of Discovery as fundamentally opposed to the Gospel of Jesus Christ, and the human dignity given to every person by God;

RESOLVED, that the Episcopal Diocese of San Joaquin, name and confess its historical and present participation in and benefit from the displacement of Indigenous peoples, which included the Indigenous Peoples of Mexico, throughout the Central Valley, High Sierra, and High Desert regions and the suppression of culture, language, and traditions and subsequent trauma, including the construction of boundaries and borders that still affects Indigenous people today. The Diocese laments the devastating results of colonial and settler mentality that continues to oppress native peoples, including the Native Mexicans who once inhabited this land;

RESOLVED, that the Diocese continues to dedicate itself to the work of reversal, reconciliation, and healing through the support of Indigenous cultural revitalization, tribal sovereignty, land and habitat restoration, and racial justice training in our Diocese. That the Diocese commit to listen and watch for new permutations of racist ideologies. That the Diocese commits to using curriculums and supporting educational and theological trainings based on the interaction between and intersection with Indigenous and non-native peoples offered by The Episcopal Church and its partners;

RESOLVED, that the Diocese continues to learn about, acknowledge and advocate for a more just and humane immigration system that respects the rights, cultures, languages and traditions of indigenous Mexicans who once inhabited what became the State of California. The Diocese recognizes the colonial and European history that informed the Mexican American War and created the boundaries and barriers established by the United States government – a history that continues to inform an unjust and inhumane U.S. immigration policy;

RESOLVED, that the Diocese commit to building intentional relationship with Indigenous leaders in strengthening and reawakening cultural ways, language, arts and crafts, and plant medicine;

RESOLVED, that the Diocese commit to faithfully steward land and habitats with humble response to Indigenous guidance and teaching for the care of creation;

RESOLVED, that the Diocese commit to begin every meeting and gathering in the diocese, its parishes, missions and institutions, with a land acknowledgement, knowing that it is but one step towards recognizing the original inhabitants of this place called The Episcopal Diocese of San Joaquin. A land acknowledgement is a critical step towards working with native communities to secure meaningful partnership and inclusion in the stewardship and protection of their cultural resources and homelands; AND

RESOLVED, that the Office of the Bishop, in consultation with the Diocesan Council, develop a reporting tool for clergy and wardens of congregations and diocesan institutions to track our collective progress towards the goals and commitments outlined in this resolution.

EXPLANATION:

As people who freely live and work on the lands of The Episcopal Diocese of San Joaquin, whose original inhabitants, which once included what is now the country of Mexico, were deprived of those allencompassing benefits nearly 200 years ago, we, as Episcopalians, are compelled to respond. We are mindful of many different Christian denominational responses to the Doctrine of Discovery and subsequent edicts resulting from its adoption and must now look at the work we have begun to do and expand our vision.

We are called by The Episcopal Church to work for the full inclusion of Indigenous people in the life, work, and leadership of the Church (Acts of Convention: Resolution 2009-D035) and must acknowledge and work to repair the long-term damage done to our Indigenous siblings. The violence and damage through the centuries were sanctioned by the Christian Doctrine of Discovery and the institutions fostered by its adoption.

The Doctrine of Discovery is defined as "the idea that Christians enjoy the moral and legal right based solely on their religious identity to invade and seize Indigenous lands and to dominate Indigenous peoples."

During 2023, the Anti-Racism Commission invited the diocese to read Sarah Augustine's book "The Land is Not Empty" and to engage in conversations with The Rev. Rachel Taber-Hamilton, The Rev. Dr. Mary Crist, and The Rev. Canon Lauren Stanley. The February 2023 Clergy Conference was centered on learning about the Doctrine of Discovery and the ways in which we, as Episcopalians in the Central Valley, High Sierra and High Desert regions can work towards reconciliation and healing with our Indigenous siblings. We are most recently reacquainted with the local atrocities practiced against our Indigenous siblings during El Camino de la Pascua where we learned of the Keysville Massacre, the forced migration of Paiute peoples from the Owens Valley to Tejon Fort, the destruction of culture and identity at the Mariposa Museum and the Indian Grinding Rock Museum, and through the story telling of BZ Smith, a local Indigenous leader.

While we have started the important work of education and theological reflection related to repudiating the Doctrine of Discovery, the passing of this resolution commits The Episcopal Diocese of San Joaquin to formally acknowledge, name and confess the ways in which we have been complicit and benefited from this doctrine, as well as codifying our commitment to further relationship building, education, reconciliation and healing.

Land Acknowledgement:

As a diocese working towards being anti-racist, we acknowledge and honor the original inhabitants of our various regions. A land acknowledgement is a critical step towards working with native communities to secure meaningful partnership and inclusion in the stewardship and protection of their cultural resources and homelands.

We acknowledge that the land on which this diocese is built is the traditional territory of the Paiute, Kawaiisu, Tubatulabal, Yokuts, Chumash, Miwok, Chukchansi, Western Mono, and Me-Wuk people.

Let us take a moment to honor these ancestral grounds that we are collectively gathered upon and support the resilience and strength that all Indigenous people have shown worldwide.

The Church's Complicity

On July 12, 2021, in a joint statement, our Presiding Bishop Michael Curry and Gay Clark Jennings+, the President of the House of Deputies, had this to say:

In Genesis, God conferred dignity on all people by creating them in God's own image – a belief that is shared by all Abrahamic faiths. We are grieved by recent discoveries of mass graves of Indigenous children on the grounds of former boarding schools, where Indigenous children experienced forced removal from their homes, assimilation and abuse. These acts of cultural genocide sought to erase these children's identities as God's beloved children.

We condemn these practices, and we mourn the intergenerational trauma that cascades from them. We have heard with sorrow stories of how this history has harmed the families of many Indigenous Episcopalians.

While complete records are unavailable, we know that The Episcopal Church was associated with Indigenous schools during the 19th and 20th centuries. We must come to a full understanding of the legacies of these schools.

As chair and vice-chair of Executive Council, and in consultation with our church's Indigenous leaders, we pledge to make right relationships with our Indigenous siblings an important focus of the work of Executive Council and the 80th General Convention.

To that end, we commit to the work of truth and reconciliation with Indigenous communities in our church. We pledge to spend time with our Indigenous siblings, listening to their stories and history, and seeking their wisdom about how we can together come to terms with this part of our history. We call upon Executive Council to deliver a comprehensive proposal for addressing the legacy of Indigenous schools at the 80th General Convention, including earmarking resources for independent research in the archives of The Episcopal Church, options for developing culturally appropriate liturgical materials and plans for educating Episcopalians across the church about this history, among other initiatives.

We also commend Department of the Interior Secretary Deb Haaland on her establishment of the Federal Indian Boarding School Initiative and the effort to "shed light on the traumas of the past." The Episcopal Church is also working to support legislation that will establish a truth and healing commission on Indian boarding school policy, which would complement the Department of the Interior's new initiative.

As followers of Jesus, we must pursue truth and reconciliation in every corner of our lives, embracing God's call to recognition of wrongdoing, genuine lamentation, authentic apology, true repentance, amendment of life and the nurture of right relationships. This is the Gospel path to Becoming Beloved Community.

RESOLVED, that the Episcopal Diocese of San Joaquin recognizes and celebrates July 29th as an opportunity to highlight the role of women in the Church;

RESOLVED, that this day acknowledge the continuing struggle of women in the church to be recognized as equal without prejudice for race, color or gender;

RESOLVED, that July 29, 2024 on the occasion of the fiftieth anniversary of the Philadelphia 11 that the churches within Episcopal Diocese of San Joaquin are encouraged to celebrate with Eucharist, prayers, celebrations and opportunities to bring attention to the significant ministry women have played through the ages, as well as today, and their hopes for a more empowered and engaged future;

RESOLVED, that we remember The Rev. Merrill Bittner, the Rev. Alison Cheek, the Rev. Alla Bozarth, the Rev. Emily C. Hewitt, the Rev. Carter Heyward, the Rev. Suzanne R. Hiatt, the Rev. Marie Moorefield, the Rev. Jeanette Piccard, the Rev. Betty Bone Schiess, the Rev. Katrina Welles Swanson and the Rev. Nancy Hatch Wittig who were ordained on July 29 in 1974, slightly more than two years before the General Convention of the Episcopal Church gave its explicit permission for women to become priests and who have come to be known as the Philadelphia 11;

RESOLVED, that we remember The Rev. Betty Rosenberg, The Rev. Alison Palmer, The Rev. Lee McGee, and The Rev. Diane Tickell, known as the Washington 4, who one year later were ordained on September 7, 1975 to the priesthood in the Episcopal Church, which was also considered outside of Canon Law and irregular;

RESOLVED, that we remember The Right Rev. Barbara Harris, the first woman bishop and the first woman of color elected bishop in the Anglican Communion when she was elected Bishop Suffragan of the Episcopal Diocese of Massachusetts, on September 24, 1988, and was consecrated on February 11, 1989; AND

RESOLVED, that we remember The Most Rev. Katharine Jefferts Schori, the first woman elected as Presiding Bishop of The Episcopal Church in 2006, and first woman Primate in the worldwide Anglican Communion.

RESOLVED, that the 64th Convention of the Episcopal Diocese of San Joaquin (EDSJ) acknowledge the more than 80 years of accomplishments of the Episcopal Relief and Development (ERD);

RESOLVED, that this Diocese celebrate the effective and life-giving ministry of Episcopal Relief and Development as it works to create economic opportunities, strengthening and promoting healthy communities, alleviating hunger and responding to disasters; and be it further

RESOLVED, that Parishes and Missions explore the ERD, Abundant Life Garden Project curriculum which is a children's faith formation program that can be expanded into a multigenerational program for worship and home experiences; AND

RESOLVED, that as encouraged by a 2009 General Convention Resolution, the parishes and missions of EDSJ annually remember and support ERD during the season of Lent through education, prayer and special offerings.

EXPLANATION:

Originally known as the Presiding Bishop's Fund for World Relief (the PB Fund), the organization was established in 1940 by The Episcopal Church. Its initial mission was to assist refugees fleeing Europe during World War II. Soon after the war, the agency's efforts expanded to include additional humanitarian assistance, focusing mostly on disaster relief.

During the 1960s and 1970s, there was a growing awareness in the US of the challenges facing people worldwide, such as hunger, disease and disasters. With increased funding, the PB Fund took efforts to the next level by increasing its operational capacity and expanding programming to incorporate sustainable development. In the 1980s, major fundraising initiatives supported responses to famine in Ethiopia, an earthquake in Mexico and a volcano eruption in Colombia. In 1988, Episcopal Migration Ministries was formed, founded out of the PB Fund to meet the growing needs of refugee ministries, allowing the Fund to focus on long-term development work.

After Hurricane Mitch in 1998, the PB Fund undertook innovative disaster relief work in Honduras that focused on integrated community development. Over four years, an entire community was constructed, with 200 houses, a school, a clinic and a church. Micro-finance activities and agricultural projects were launched to create economic opportunities and improve food supply. The combination of rebuilding and development through micro-finance and other initiatives helped spur economic growth in the devastated region. This integrated approach became a core element of the agency's disaster relief work.

In 2000, the PB Fund was renamed Episcopal Relief & Development to emphasize its disaster relief work and its increased programmatic focus on integrated community development. Two years later, Episcopal Relief & Development was incorporated as an independent, 501(c)(3) organization. In 2003, the Board of Directors decided to shift from administering small grants for domestic and overseas projects to implementing long-term development programs and partnerships worldwide.

Over the last few years, Episcopal Relief & Development's programmatic reach has extended dramatically. In 2004, the agency worked in 21 countries, reaching nearly 250,000 people annually. Now, Episcopal Relief & Development is working in approximately 40 countries and touches the lives of close to 3 million people each year.
